

# Gina calls for review of mining law in PH

DAVAO CITY—Environment Secretary Gina Lopez on Thursday said she would initiate a review of the 1995 Philippine Mining Act that opened the country's mining sector to 100percent foreign ownership, which she described as "treasonous and should not have been passed at all."

"It must be reviewed," Lopez said, citing a recent statement of Jesuit priest Joel Tabora, president of Ateneo de Davao University, about the mining law.

"In my view, the 1995 mining act is treasonous because our Constitution says that the minerals belong to the state, which means they belong to the people," Tabora said.

Speaking to local reporters on the sidelines of the Min-GINA/A16

danao Environment Summit, Lopez said the mining law allowed "foreign companies to take the country's minerals away almost for free."

"It's time for all of us to demand that this treasonous law be repealed and replaced with a [law] that would be in the interest of the Filipino people," she said.

"My commitment for Mindanao is social justice," Lopez said.

"The definition of social justice is that the resources of Mindanao must necessarily be enjoyed by the people of Mindanao," she added.

Lopez called for the shutdown of Claver Minerals Development Corp. in Surigao del Norte province for violations of environmental laws.

## Gina calls for review of mining law in PH

#### 3 firms under audit

She said three other big mining companies are undergoing an environmental audit.

Undergoing audit are Taganieffecto Mining Corp. and Greenand Stone Resources Corp., both in Surigao del Norte and Sagittarius Mines Inc. in Tampakan, look South Cotabato province.

Taganito is involved in nickel mining, Greenstone in gold processing and Sagittarius in gold and copper mining.

The results of the audit are expected to be submitted to the Department of Environment and Natural Resources (DENR) within a week, Lopez said.

She said the audit results would be the basis of a DENR decision whether to allow the companies to continue operating.

"It's not only the technical [aspect] that is being audited, but also [the] social aspect, its effects on the water, health and the environment," she said.

Lopez said she would also look into mining operations that threatened two protected areas in Davao Oriental province, including Mt. Hamiguitan's pygmy forest.

"A mine in between two protected areas? That's crazy," Sinsaid.

"I will not wait for even and hour, they'll have to go," she said, referring to mining companies that have been audited, and found to be degrading the environment.

#### Family business

Lopez said she would not hesitate to "use the full force of the law" if Energy Development Corp. (EDC), owned by her family, would be found to have violated environmental regulations.

The DENR chief was responding to complaints from residents of Negros Oriental province, where EDC plans to expand the operation of its geothermal power plant on Mt. Talinis.

Residents and environmentalists running the Save Mt. Talinis Campaign have denounced the company for allegedly damaging the protected forest on the mountain, particularly through cutting old-growth trees.


"We will look into this and I assure the public that the DENR will be fair through the entire process and take into account the concerns of all," Lopez said in a statement.

EDC, which operates a 223-megawatt geothermal plant in Valencia town, submitted an application for environmental clearance certificate for the expansion of the plant's capacity by 60 megawatts, she said.

Lopez said the Environmental Management Bureau had held public hearings on EDC's application.

"Through good environmental governance, we aim to harmonize our economic activities with nature through sound practices that will not only address climate change but [also] ensure the sustainable use of our resources, conservation and preservation," she said.

"Our concern for the environment and the pursuit of the common good transcends familial and other ties," she added. With a report from Ronnel W. Domingo in Manila

## Philippine nickel ore used in China's island building?

Was Philippine soil used in China's island building in the disputed seas? That news, attributed to Zambales governor Amor Deloso, needs confirming. More so since it infers treason by sinister parties.

But the report needs some correcting first. Published last week, it quoted Deloso as saying that two mountains in his province were leveled as landfill for China's reclamation of Scarborough Shoal. Seven nickel mines operated by Chinese nationals supposedly did it during the tenure of his predecessor Hermogenes Ebdane. The seven mines were not identified. Deloso further was quoted as citing a Dept. of Foreign Affairs estimate of the reclamation at 3,000 hectares. Thus the shoal allegedly has been converted into an artificial island. Severely affected was the environment of Santa Cruz municipality, and the marine resources of Scarborough.

Fact is, while China invaded Scarborough in 2012, it has not made the shoal into an artificial island. The island making occurred in 2013-2014 in seven other portions of the South China (West Philippine) Sea. Like Scarborough, the seven are within the Philippines' 200-mile exclusive economic zone. Those are Mischief Reef, Fiery Cross Reef, Cuarteron Reef, Gaven Reef, Johnson South Reef, Hughes Reef, and McKennan Reef. China began reclaiming Mischief in 1995, and expanded the area, along with the six other rocks. The artificial islands consist of sand from the seabed and rocks. Portions have been concreted as seaports. On Fiery Cross is a three-kilometer long aircraft runway. The DFA and the US State Department estimate the reclamation to cover 3,200 acres, or 1,300 hectares.

Scarborough, also called Panatag Shoal and Bajo de Masinloc, is a traditional Filipino fishing ground. It is 123 miles from the coast of Masinloc, Zambales. The recent ruling of the UN arbitral court declared Scarborough as a traditional fishing ground of other East Asians as well.

This column exposed starting 2012 the destructive nickel mining in Santa Cruz and surrounding Zambales towns. The provincial capitol had granted hundreds of small-scale mining permits. With Filipinos as fronts, Chinese nationals actually engaged in large-scale mining. Not mere picks, shovels, and wheelbarrows were used, but dozens of heavy excavating equipment and bulldozers, and hundreds of dump trucks. Hundreds of thousands of tons of nickel ore - rocks the size of a fist to a football – were loaded onto bulk-cargo ships and transported to China. Three big Chinese miners were involved: Nihao, Wei-Wei, and Jiangxi.

Mickel is used in the steel and communications industries. It is a crucial component in China's weapons and shipbuilding, as well as spyware. The processed nickel from Zambales likely was used in China's equipment to grab Scarborough.

The news item went on about the destruction of Zambales' forests and Scarborough's marine resources. Environment and Natural Resources Sec. Gina Lopez was reportedly aghast with the news. She has ordered an investigation, and promised to punish any department underling involved in the environmental mess.

This column in fact reported the harmful effects of the nickel mining on the townfolk's health. The deforestation dried up the rivers and destroyed wildlife. Seas were muddied. Floods ruined farmlands. Emissions from the hundreds of dump trucks made northern Zambales the most afflicted with respiratory ailments.

The Noynoy Aquino administration paid no heed then. The governor, a former police general, once headed the close-in security of President Cory Aquino's family. Noynoy was said to be his friend. Police and natural resources officials did not enforce health and environment laws against the Chinese nationals.

Still, was Philippine soil used to reclaim the rocks and underwater elevations that China grabbed? And did the filling material also come from other nickel mines, including in Surigao and Agusan?

It would help Secretary Gina's investigators to gather data from various agencies. From the Mines and Geosciences Bureau they can get info on how much nickel ore was extracted in Luzon and Mindanao in 2012-2014. One mine in

Agusan, operated by friends of Noynoy and campaign contributors of his Liberal Party, had in fact over-extracted millions of tons of ore. President Rody Duterte has denounced that miner, SR Metals Corp., for environmental ruin.

With the data, the investigators can calculate how much ore could have been used to reclaim 1,300 hectares of reefs up to, say, ten meters high.


How was the ore transported to the artificial islands? Investigators should study the aerial and satellite photographs of the Chinese rush construction. Those show that not only dredgers were used to suck up sand from the seabed onto the rock formations. There were also dozens of hauling barges called LCT (Landing Craft Tank). It would surprise the investigators to find out that China sold very cheap LCTs to Philippine nickel mines.

The Maritime Industry Authority would have the figures. Investigators would be able to calculate, at 300 tons load capacity per LCT, how many trips it took to transport the nickel ore to the reclamations.

Now why would China use nickel ore as landfill instead of processing it for steel mills? The answer lies in the gap between low-grade Philippine nickel and the Chinese processors' high-grade preference. Also worth looking into is the location of the ore processing plants far inland of China. Loading and unloading the ore from ships to trains would have been more expensive than converting the ore into instant landfill.

The intelligence agencies would have more info on that. They likely know too, which Filipino nickel miners collaborated in the Chinese reclamation binge.

Probers must get figures on how much ore was extracted in Zambales and Mindanao, and how many barges were used.



## Philex defers comm'l operations of Silangan Mine in Surigao to 2020

he commercial operations of Philex Mining Corp.'s Silangan Mine in Surigao del Norte will no longer happen between 2018 or 2019 as the company initially planned as the it may still need more time to work on the project's feasibility study.

Silangan Mine, one of the company's prospective mineral reserves in Surigao del Norte, is Philex Mining's next big potential mining venture, next to its Padcal copper-gold project whose whose mine life is expected to end in December 2022.

Philex Mining Chairman Manuel V. Pangilinan said that Silangan Mindanao Mining Corp. (SMMCI), a wholly owned subsidiary of the company, has pushed back mining operations in Silangan Mine.

at the mine site by 2020, a year later than it earlier expected.

"We are currently completing requirements for the feasibility study on Silangan," Pangilinan said.

It was reported before that Philex is looking at 2018 or early 2019 for the commencement of initial ore production at the the site.

As of end 2014, the company has already poured in as much as P13 billion for the project's initial exploration and related works, on top of the project's total funding requirement of US\$1.2 billion.

Pangilinan, however, said that the estimated cost of developing its new Silangan coppergold mine has been reduced to US\$900 million.

The Silangan project is located in Surigao del Norte, at the northern part of Mindanao. It combines the development of Boyongan and Bayugo deposits, which are comprised of gold, copper, and silver.

## Audit of Mindanao mining operations to begin next week

AVAOCITY—Environment Secretary Regina Paz L. Lopez disclosed the near completion of a comprehensive audit of all mining operations in Mindanao, warning of immediate closure of violators.

Lopezsaidfinaljudgment on each mining operation would depend on the performance audit.

"To all those who would not pass the audit, I will not wait one hour to close it. It will not be allowed anymore," she told a news briefing shortly before a Mindanao environmental summit at the Ateneo de Davao University.

Lopez did not say how the audit went so far and where the audit is currently done.

Also next week, the Department of the Environment and Natural Resources (DENR) would enter into an agreement with the Army to crack down on illegallogging operations.

Mr. Duterte earlier gave the go signal to the revolutionary New People's Army to conduct its own antiillegal-logging crackdown and punish suspected violators, according to its own revolutionary justice.


Lopezsaidshe would create a civic-organization arm in the DENR. "It would not be a desk. It would be an arm within the DENR."

The DENR is also about to craft a more activist agenda to find possible solutions to the "most pressing environmental problems facing Mindanao today."

The agenda would come out in Friday's strategic-planning workshop with select representatives of civil-society organizations.

The bulk of the agenda items would emerge from a two-day Mindanao environment summit, which began on Thursday and participated in by 4,000 people, mostly students of Ateneo de Davao University, a key partner of the DENR in holding the summit.

# Duterte: Mining, logging are 'sunset' industries

ADDRESSING a conference on environmental issues in Davao City on Thursday, President Rodrigo R. Duterte stepped up, with his trademark candor, his administration's stand on the mining and logging industries, and on the influence of what he called the "oligarchy" in business and politics.

Mr. Duterte's remarks at the Mindanao Environment Summit held in his hometown were a continuation of Wednesday's remarks partly on the oligarchy, wherein the President singled out businessman and Marcos-era trade minister Roberto V. Ongpin to amplify his point.

On Thursday afternoon, at the summit that already took a lively turn that morning with the remarks of his environment secretary, Regina Paz L. Lopez, Mr. Duterte branded the mining industry as "a sunset industry, almost."

He also included logging as being "wala na talaga (no more), it's not even sunset time."

"It's already too late... if there is 24 hours in one day, logging is on its 25<sup>th</sup> hour. *Tapos na 'yan* (It's finished)," he added.

"Many will get mad, many will get angry, many would like to maintain the status quo... maybe elected officials in power, they will hang on to that. Kaya dahandahan kong sisirain iyan (That's

why I will destroy this [industry] slowly). And open all opportunities to all Filipinos. Irrespective of tribe, race or religion."

"Yung mga mina napupunta iyan sa mga oligarch. Walang iba

'yang ginawa kung 'di mag influence-peddling (Mining goes to the oligarchs. All they do is influence-peddling)," Mr. Duterte also said.

"That is why I am fighting a monster. I am just two months old there but believe me I will destroy their clutches sa ating buhay (in our lives)."

But even as Mr. Duterte asserted that "the wealth of this country is owned by only a few guys," he also said: "Hindi naman lahat mayaman na (Not all the rich are) oligarchs."

Some, he said: "built their empire through the years. For example, I'm not saying it because she's here. Gina — she's a billionaire but look at the way she treats herself. She's a crusader, and she loves the country, and she hates oligarchs," Mr. Duterte said of his environment secretary, who is a member of the Lopezes of Iloilo, a long-influential family in business, politics, and media.

#### **'SOCIAL INJUSTICE'**

For her part, Ms. Lopez gave a pep talk at the summit that was directed at the broader audience of "business interests" and "foreign interests." "When the resources of one land are destroyed for the business interests of a few, and when the resources of one land are not enjoyed by the people of their land, it is social injustice," she said.

"Mindanao must be for Minddanaoans, must be for Mindanaoans, which will be for Mindanaoans. You live here. You live here. This is your land. Why is

Mindanao being used by business interests? Hello! Why is Mindanao being used by foreign interests? Hello!" she added.

"Ang yaman yaman na nila, di ba? (They're already too rich; aren't they?)"

"Businesses have no right to kill our land, sea, and air for their own interests. DENR officials have no right to allow this to happen."

In her address, Ms. Lopez called in an official of the Protected Area Management Board to have him explain an authorized mining project that "is not acceptable to me."

"And if you or anyone else in the group [will allow this], I will shoot you. Babarilin kita. You f—ing do it. You understand? You will not let injustice reign in this land. Is that clear?" she told the official as recorded in a video posted by the ABS-CBN News Web site.

Soon after she sought to her stage another official, newly appointed Mines and Geosciences Bureau chief Mario Luis J. Jacinto, to make him affirm that no mining company or business entity can


Meanwhile, a group of largescale mining companies in the Davao Region criticized their noninclusion in this forum.

## Not enough soil in Zambales mountains to fill Scarborough, says ex-Gov. Ebdane



IBA, Zambales — Former Zambales Governor Hermogenes Ebdane Jr. described as absurd allegations that he sold Zambales mountain soil to the Chinese for their supposed reclamation of Scarborough Shoal.

In a radio interview, Ebdane said there is not enough soil in the mountains of Sta. Cruz, Zambales to 6

turn Scarborough Shoal into a military installation.

"Do the math!" Ebdane dared, stressing that 450 trucks would need more than one trip each to move 3,500 hectares of land that was allegedly used in the reclamation of Bajo de Masinloc.

"Nickel laterite itself is valuable and is sold to manufacturing firms using nickel to make stainless steel from ordinary steel. And no country or businessman in their right mind would buy a material with a high price of per

cubic meter just to use it as a reclamation material," he stressed.

The former Public Works Secretary explained that the material commonly used as reclamation medium is shale. "For reclamation medium, the material used should be heavier than water. So the most commonly used material is shale."

Nickel laterite, he said is "mud that sticks to your shoes when you're up in the mountain. It is mud, and mud when mixed with water, would dissolve." If nickel laterite was indeed used in the

reclamation of Scarborough Shoal, the water near the area would have reddened.

#### Mountain sale

Ebdane pointed to records which show that the Department of Environment and Natural Resources (DENR) gave permits to mining companies like Eramin, Benguet, in 2004. On that year, mining firms conducted explorations on the area. In 2007, the mining companies started operations. "The governor of Zambales from 2004 to 2007 was Vic Magsaysay, and mining was in full operation from 2008 to 2012," he added. After Magsaysay stepped down, (Gov. Amor) Deloso

was the governor from 2008 to 2010 during the height of mining operation in Zambales.

Ebdane served as Zambales governor from 2010 to 2016.

Ebdane said mining permits came from the DENR. "There is no power or authority for the governor of Zambales to grant a permit. Paano ko maibebenta yung tatlong bundok eh sila naman yung nakaupo noon? (How was I able to sell three mountains when it was them who was in power)," he asked.

#### No power over mining

He pointed out that the governor doesn't even have the power to stop the mining operations. Environment Secretary Gina Lopez said heads will roll if a fact-finding team tasked to investigate China's alleged use of Philippine soil in its reclamation

project uncovers any wrongdoing on the part of local and environment officials.

"That's horrible. I will find out whoever gave the permit. China can never be allowed to use our soil as their landfill. We're gonna look into this and make it never ever happens," Lopez said during a radio interview.

"If there are DENR officials, they will be made accountable... Heads should roll. If the truckloads came from us. We should be aware. If they were getting truckloads of our soil, there were probably some trail," Lopez added.

Gov. Deloso who suspended mining operations in the province earlier told Manila Bulletin that the Chinese through some of their mining companies have been operating in the province's mountains, extracting soil and boulders that were used to build China's artificial island measuring around 3,500 hectares in the reclaimed area near the Scarborough Shoal.

Deloso said the Chinese used "the boulders as the bedrock and the soil as the foundation of its bases." (With a report from Franco G. Regala)

government.


"Our resources are being enjoyed by those with the right connections. I do not brag. Had I not become president, I would not know what will happen to the country. It's pitiful," he added.

# DENR to end illegal logging, mining in



## eight days - Lopez

AVAO CITY – Environment and Natural Resources (DENR) secretary Gina Lopez said she will end illegal logging and mining operations in the country in eight days, with her "Duterte team" backing her up in the protection of the environment.

In a press conference on Thursday at the Ateneo de Davao University (ADDU), Lopez said she wants to copy President Rodrigo R. Duterte's hardline stance against drugs and criminality in her fight for environmental protection.

She said that she is set to sign a memorandum of agreement (MOA) on Monday next week with Philippine National Police (PNP) chief Ronald Dela Rosa, Armed Forces of the Philippines (AFP) chief of staff Lt. Gen. Ricardo Visaya, and Interior and Local Government secretary Mike Sueño to assist the DENR in the implementation of stricter monitoring and protection of the country's natural resources.

"The MOA, in essence, commits that the police and the military will assist the DENR in protecting the resources of the country, including the DILG. We will not allow any illegal activities that adversely affect the lives of the people," she said.


The DENR secretary said she will only consider nothing but the "rule of law and the common good" as she threatened to punish the logging and mining companies who cause suffering for many people.

She said she tasked the former chief of police at the Ninoy Aquino International Airport (NAIA) Peter Mutoc whom she described as her "General Bato," the moniker of PNP chief Dela Rosa, as enforcing officer of the DENR-Law Enforcement and Operations to monitor and enforce the cease and desist order to erring companies and local government officials.

Mutoc said that they will treat illegal loggers and miners just like "drug lords" but within the bounds of law.

Lopez said they are also reviewing the environmental compliance certificate (ECC) and auditing both the metallic and non-metallic mining companies that will be completed next week.

Leo Jasareno, head of the DENR's Mining Audit Team, said that they can

stop the operations if they find out that companies fail to comply with the regulatory standards.

He said the DENR's mining audit is a comprehensive assessment and will be the basis for the "final judgment" whether to close the mining companies.

"I don't want DENR to be just a regulatory agency. I want to work with the people of Mindanao such that their recourses can lead to their quality of life," she said.

She called on the people of Mindanao to make the region a model of social justice and upliftment during the Mindanao Environment Summit also held at the Ateneo de Davao University.


Lopez pointed out that Mindanao's resources are for its people and not for business and foreign interests.

Some 4,000 representatives from civil society, including indigenous peoples, farmers, fisher folk and the academe attended the summit highlighted by the presentation of the state of the Mindanao environment (SOMEDay).

Lopez decried the environmental damage brought about by several business interests, particularly the mining sector, as shown in SOMEDay, calling the destruction, a "social injustice."

She pointed out that it "hurt her" to see and hear communities in damaged areas losing their livelihood and their resources due to the seeming indifference of mining and other businesses taking advantage of Mindanao's wealth.

"We should all work together to make sure that Mindanao's resources are enjoyed by the people of Mindanao," she said.







### Prelate on Laguna Lake: It will die

CALAMBA CITY—Likening the slow death of Laguna Lake to murder, especially of innocent people, Catholic Church leaders and government officials have appealed to residents in lakeside communities and industries to do their share to save what remains of the crucial body of water.

In a gathering in this city last week, retired Manila Archbishop Gaudencio Cardinal Rosales said it is the duty of everyone to take care of the lake by not contributing to its death.

"Time will come, that if Laguna Lake is not preserved and protected, it will no longer serve life. It will die. It will be killed," said Rosales in his homily during a Mass here.

The Mass was celebrated as part of an activity to call attention to the condition of the biggest freshwater lake in the country that covers communities in the provinces of Laguna and Rizal, and Metro Manila. More than 4,000 people, including government officials cand workers, students and appriests, attended the event.

Fr. Robert Reyes, the "runining priest" who is also an environmental advocate, chalblenged the crowd to be involved in efforts to save Laguna Lake ofrom extinction.

Reyes, citing accounts of scientists, said the lake had become heavily silted and polluted. Fish pens also crowd the lake, leaving little fishing ground to small fishermen who still depend on the lake to survive.

"Worse than a marshland, Laguna Lake would become a 'Smokey Mountain' in the future because of the continuous flow of dirt and wastes," he said.

"Owners of private corporations and industries are the real pests in our environment because [they] exploit and destroy nature just for money without due regard for its protection and sustainability," he said. Lawyer Ipat Luna, who represented Environment Secretar Gina Lopez in the activity, urge those, who attended the event to help in protecting the dying lake.

She said residents could of their share in saving Lagur Lake by ensuring that the wastes do not reach the lake.

Luna said people shou avoid dumping domestic wast into the lake that coufurther poison it.

"[Let us nurture] watershe to protect the lake and t environment," she said.

Mayor Cesar Perez, of I Baños town, urged people to operate in efforts to save the laby not using it as a septic tank.

#### Negros expansion

NERGY Development Corp. (EDC) President and COO Richard B. Tantoco welcomes Environment Secretary Regina Paz L. Lopez's announcement to investigate the alleged violations committed by the company in its operation in Negros Oriental.

"We look forward to the opportunity to show Secretary Lopez that our Negros expansion is perfectly above board and the allegations about expanding into Mount Talinis are untrue. Responding to complaints from local residents in Mount Talinis against the EDC's planned expansion of its geothermal plant in Negros Oriental, Lopez on Thursday said she will not hesitate to "use the full force of the law" to protect the environment and preserve the ecological balance of Mount Talinis and other biodiversity areas.

EDC is one of the companies owned by Lopez's family. It is a subsidiary of First Gen, a pioneer in renewable-energy development in the Philippines.

Lopez vowed to look into the complaints of residents and non-governmental organizations based in Negros who oppose EDC's expansion, saying it would lead to destruction of old growth forests on Mount Talinis.

"We will look into this and I assure the public that the DENR [Department of Environment and Natural Resources] will be fair through the entire process and take into account the concerns of all," Lopez said in a statement.

EDC, which operates a 223-megawatt geothermal plant in Valencia, Negros Oriental, submitted an application for environmental clearance certificate for the expansion of the plant's capacity by 60 additional megawatts.

The DENR's Environmental Management Bureau office in the region has held public hearings on the application to gather the position and opinions of stakeholders.


"Through good environmental governance, we aim to harmonize our economic activities with nature through sound practices that will not only address climate change, but ensure the sustainable use of our resources, conservation and preservation" Lopez said.

Lopez added that she adheres to strict compliance with environmental laws, rules, regulations and standards, and pointed out that under her watch, "there is no room for violation."

"This is our guiding principle, our commitment, our preaching and our practice in our quest for sustainable development. This is our call to all stakeholders," she said. "Our concern for the environment and the pursuit of the common good transcends familial and other ties."

Zeph Repollo of 350 Pilipinas earlier accused EDC of killing 576 trees on Mount Talinis or Cueernos de Negros a few years back.

Mount Talinis is a key biodivesity area spanning 23, 565 hectares. It covers the towns of San Jose, Sibulan, Dauin, Zamboanguita, Siaton, Santa Catalina, Pamplona, Amlan and Valencia, the EDC's base of operation.







## More investors eye Philippines for waste-to-energy ventures

HE government is now seriously looking at waste-to-energy (WTE) or energy-from-waste to help address the country's garbage problem, an official of the National Solid Waste Management Commission (NSWMC) said on Thursday.

Potential investors from European countries, Korea, Japan, Australia, United States and China are now looking at the Philippines for possible WTE ventures, said Ely Ildefonso, executive director of the NSWMC.

There are also "homegrown" technology developers who expressed interest venturing into WTE, he added.

Experts are eyeing WTE as solution to the country's perennial garbage problem as WTE technologies also help reduce greenhouse-gas (GHG) emissions.

The NSWMC has recently approved the WTE guideline that would allow the use of technologies that would convert waste into viable en-

ergy, Ildefonso added.

"One of the resolutions passed by the NSWMC is the waste-to-energy guideline. The benefit of this is to reduce the greenhouse-gas emission emitted by garbage in open dumps. We can now convert all these GHG into energy," he said.

"The guideline adopting any technology that can convert waste-to-energy will be allowed with certain standard, and following existing laws. Waste-to-energy technologies do not necessarily involve incineration," Ildefonso said.

WTE technologies would reduce the country's GHG emission while effectively reducing up to 95 percent the volume of wastes produced every day. In Central Luzon, he said, agricultural wastes from sugarcane could be disposed of through gasification.

There are now two waste-to-energy plants in Central Luzon, he said.

Following the approval of WTE guideline, he said a good number of investors have started to inquire about the possibility of doing business using various WTE technologies.

Among the WTE technologies allowed under the guideline are gasification, pyrolysis, bioreactor, biomethanation, hydrolysis, pyrolytic gasification, plasma and other thermal processes.

"These technologies do not use incinerators. There are a number of waste-to-energy technologies that we can adopt to reduce GHG and convert garbage into energy," Ildefonso said.

The Clean Air Act prohibits waste incineration in the Philippines.

Environmental groups have expressed opposition to a proposal to lift the ban on the use of incineration in the Philippines to address the looming garbage crisis in the Philippines.

Environment Secretary Regina Paz L. Lopez said she is not in favor of any kind of pollution. "As long as it does not pollute the air, I am open to possibilities," she said.

The NSWMC, Ildefonso said, is also considering possible public-private partnerships as an option, but private companies capable of financing are free to invest on their own, Ildefonso said.

## Rody to Gina: Destroy Laguna fish cages

RESIDENT Rodrigo Duterte on Wednesday ordered Department of Environment and Natural Resources Secretary Regina Paz Lopez to destroy the fish pens crowding the Laguna de Bay and instead transform it into an economic haven.

Laguna Bay is a 911-square-kilometer body of water into which 21 river tributaries drain. It reportedly supplies 30 to 40 percent of the total fish requirement of Metro Manila.

Its 90,0000 hectares of brackish water experienced deterioration

courtesy of the past administrations' development projects under the Laguna Lake Basin 2020 scheme, which aims to convert the Laguna de Bay into a full commercial, industrial and economic hub in the year 2020.

"One of these days, I will destroy the fishpens. They cannot remain for all time at the expense of the poor fishermen. I've warned their owners," Duterte said during the courtesy call of the Parish Pastoral Council for Responsible Voting late Wednesday night.

"I'm saying in a diplomatic way that Laguna Lake shall be transformed into a vibrant economic zone showcasing ecotourism by addressing the negative impact of the watershed destruction, land conversion and pollution," Duterte added.

The President's order comes in the wake of militant fisherfolk group Pambansang Lakas ng Kilusang Mamamalakaya ng Pilipinas (Pamalakaya-Pilipinas) warning

Lopez about the possible implications of transforming the Laguna de Bay into an eco-tourism zone following reports that fish products does transforming it to an ecozone sigfrom the lake acquired high level of toxic chemicals that are dangerous to human's health.

"This is not the first time fish contamination was reported in the media but it was never proven. The people around the lake and even the whole of Metro Manila consume the fish from the lake and yet there were no reported bad effects," said Roman Antazo, Pamalakaya secretary general and a fisherman from Laguna Lake, in a statement.

If the conversion pushes through, it would affect tens of thousands of fisherfolk families living and rely-

ing on Laguna Lake, Antazo said.

"Let's say fish from Laguna de Bay isn't safe anymore due to pollution; nificantly solve the problem? No, because untreated water wastes dumped into the lake come from thousands of industrial and commercial establishments around it," he said.

Transforming the lake would also create a major shortage of fish in the National Capital Region, Pa-

malakaya said.

Lopez recently bared "initial plans" to carry out the President's order which include removing fish pens from the lake, reconfiguring the sewage systems of the lakeside communities and reforestation of the mountains around it.

## Dismantle fish pens in Laguna – Duterte

RESIDENT Rodrigo Duterte has ordered the dismantling of illegal structures at the Laguna Lake, particularly fish cages that affect the livelihood of small fishermen.

The 90-hectare lake supplies more than half of Metro Manila's milk fish and tilapia requirements, but supply has been dwindling because of illegal fish pens.

In his speech at the environment summit in Davao City on Thursday, Duterte vowed to give priority to poor fishermen in the use of the Laguna de Bay.

He noted that small fishermen eking out a living at the lake are left with very little area to fish because most areas of the lake had been allocated for private fish pens owned by big corporations.

"The poor will be my priority. Wherever there is inequality, it will be resolved in favor of the poor as against the rich," the President said.

Duterte directed Environment Secretary Regina Lopez and Agriculture Secretary Emmanuel Piñol to reduce the area occupied by retired generals and local officials.

"I told them dismantle all those things and give back Laguna de Bay to the poor fishermen of the country," the President said.

As of June 30, 2016, there were 357 registered and unregistered fishpen owners operating at the Laguna de according to the Laguna I Development Authority.

In his first State of the Na Address, Duterte said he plai convert the Laguna de Bay int eco-tourism zone.



## Caloocan drive vs waste slated

CALOOCAN City Mayor Oscar "Oca" Malapitan launched a citywide war against waste in order to maintain cleanliness in all communities as part of the city's intensify campaign against dengue.

The three-day campaign in each of the city's 16 zones dubbed as "Oplan Clean Agad" include information dissemination through door-to-door flyers distribution and barangay-level lectures on dengue prevention on day one.

On Day two, a clean-up proper, de-clogging of water-ways like creeks and canals, emptying of cans, bottles and other receptacles of stagnant water, removal of trash and clutters are scheduled while on day three, fogging, misting and larvicidal treatment of canals and drainages to eliminate the breeding grounds of mosquitoes will be implemented.


This year's opening salvo of Oplan Clead Agad will be held in the first three clusters wherein the first cluster in Zone 13, Barangay 132-155 will be held on August 5, 6 and 7. Second cluster in Zone 12, Barangay 132-141 on August 12, 13 and 14 and the third cluster in Barangay 178 on August 19, 20 and 21. Other zones and barangays will be scheduled on later dates.

Mayor Malapitan stressed the need to maintain clean surroundings at all times since prevention is better than cure. "The months of June-August register high incidence of dengue cases specially among children." Malapitan said.

"The city spends so much in treating dengue victims in hospitals. If we can drastically reduce the dengue incidence in Caloocan, the city would save a big amount of funds, which can be re-channeled to building new health centers in the barangays," the mayor added.

Apart from this annual campaign against the potentially fatal disease, during the entire year, the Caloocan Health Department and Environmental Sanitation Services (ESS) will regularly conduct measures to raise dengue awareness and promote a clean environment.

#### Go Gina, go!

Some people think Gina is nothing but a mantra mumbling do-gooder who belongs to the Save the Earth fringe and is ill-equipped to perform her tasks as DENR secretary. They are totally mistaken.

Gina has been at it for decades now. She knows the problems and is a passionate crusader for environmental protection. She has also being fighting for the rights of our marginalized citizens, from abused children to the poor people in far off communities victimized by the big guys.

Gina knows how difficult and how dangerous her task is. She lost a number of her own people who were killed in the process of Gina's seemingly impossible goal of reforesting the Balara watershed area many years ago. But she is tough as nails and is not easily scared off by problems or threats.

Now she has to clean up the Laguna de Bay after President Durterte directly ordered her to do so. She also got orders to close the mines that have violated conditions of their permits, specially with respect to environmental issues.

A big Canadian company listed in the Toronto Stock Exchange suffered an accident and abandoned its clean up obligation and the damage to the environment is felt up to today.

I had visited the Marcopper mine site in its glory days and they seem to have been doing everything right, in a word, responsibly. They had a medical facility on site that also served the local community. Their power generators also provided power to the locals. But when tragedy struck, they simply left and abandoned everything.

Then we have big local mining companies like Philex. It recently had an accident, but Philex showed what being responsible meant. It helps that it is a local company and it had a reputation to protect and nowhere to flee. They made things right again. This is the kind of mining company Gina must help become the example for the rest.

The mining industry is required by law to rehabilitate fully exploited mine sites, and by requirement of law must set aside money to ensure this happens. This is what Sec. Gina must be strict with. Perhaps it is necessary to regularly assess the fund balance to see if there is a need to top it up.

I am confident the mining industry and Sec. Gina can live together, if they can just sit back a moment and figure out where their interests converge. As a public official, Gina is obligated to uphold the national interest... so should the mining industry.

An enlightened private sector industry shouldn't be too focused on the bottom line and sacrifice public good. As President Duterte puts it, it is as simple as that. And for now, we can only cheer Gina from the sidelines and urge her to go, go and go get the job done.



# Water district officials sacked

OROQUIETA CITY—The Office of the Ombudsman has ordered the dismissal from the government service of 10 top officials of the water district in this capital city, a court report recently stated.

The report said Ombudsman Conchita Carpio-Morales found the officials of the Oroquieta City Water District "guilty of grave misconduct."

The Ombudsman identified the discharged executives as general manager Ricardo Ravacio, corporate account analyst Leonita Loma, board member Diego Yew; division managers Rosalyn Policarpio, Aljun John Berenguel and Bobith Baloncio; finance officers Nelda Antonette Cabatingan, Arleen Adlaon and Joey Kim Villabert; and former district chairman Evelyn Catherine Silagon.

The report said the aforementioned OCWD top personnel were meted "the accessory penalties of cancellation of eligibility, forfeiture of retirement benefits, perpetual disqualification from reemployment in the public service and barred from taking the civil service examinations."

The Ombudsman, in a separate decision, added that "the respondents would be indicted for multiple counts of malversation of public funds."

The report noted that graft investigators confirmed the findings of the Commission on Audit that the accused local water district officers "caused 91 fund withdrawals totaling P790,515.80 which were spent as organizational costs and debt write-offs despite insufficient supporting documents."

The Ombudsman further said "another P5,543,716.85 in public funds were also disbursed with no appropriate supporting papers."
