

## DENR to assist Petron on ash transfer

ENVIRONMENT Secretary Regina Lopez on Thursday said she would soon issue a permit to allow Petron Corp. to transfer an ash stockpile at its Limay, Bataan refinery to a cement plant in the same complex.

Following a dialogue with residents near the refinery, Lopez said she would ask Ramon Ang, president of Petron's parent San Miguel Corp., to submit an application to transport the ash, which would be processed immediately.

"Right now it's the mountain. The mountain is causing all the health problems. The mayor didn't give the

permit. I'll give their permit and they are gonna take it out," Lopez was quoted as saying in a statement. "They're gonna silo it so it doesn't go out at all and we'll sec it happening."

Residents had complained of the ash supposedly from the Limay refinery, prompting the Environmental Management Bureau (EMB) under the Department of Environment and Natural Resources (DENR) to issue notices of violation against the Petron refinery and SMC Consolidated Power Corp., which is building a coal plant in the complex.

Petron and SMC Consolidated are

subsidiaries of San Miguel, one of the country's biggest conglomerates.

Lopez said she would exert all efforts to ensure that Petron and SMC Consolidated would "comply with environmental laws and not cause people to suffer."

"I am sure that Mr. Ang would not do something that would jeopardize a billion-dollar operation. I commit and make sure that you (the community) would be okay." Lopez was quoted as telling Limay residents.

EMB Acting Director Jacqueline Caancan said the bureau would have to make sure the ash being released from the refinery complex is not toxic.

"If found non-hazardous, the materials could be dumped in a sanitary landfill or allowed to be disposed of through other equally safe means," Caancan said. "Otherwise, the company would have to secure a permit to transport from the EMB," she added.

On Wednesday, Ang denied that Petron was causing environmental and health problems in Limay.

"We don't even need to dump anything, because whatever we generate everyday, we haul this to the cement plant—this becomes calcine limestone; with sulfur and everything, it's called gypsum powder," Ang told reporters.

He explained that the operations in Bataan mostly produced limestone powder, which is certified by the DENR as non-hazardous and is used as raw material for manufacturing cement.

## FIRM TO FOOT MEDICAL BILLS AMID ASH COMPLAINTS

Are the health problems of residents in Limay, Bataan, caused by ashfall or spill from a byproduct storage facility being used by San Miguel Corp. (SMC) subsidiaries?

That will be settled once and for all by a study to be conducted by the Department of Environment and Natural Resources (DENR).

Environment Secretary
Gina Lopez asked anticoal
plant protesters and Bataan
residents on Wednesday to
give the DENR a week to coordinate with the health department to validate the
complaints.

Limay residents, particularly those in Barangay Lamao, started complaining late last year of skin and respiratory diseases, as well as pollution in the air, rivers and coastlines, blaming them on windblown and soil-seeping ash allegedly from the stockpile of byproducts from the SMC Consolidated Power Corp. (SMCCPC) plant and a coal-fired plant of the Petron Bataan fuel refinery. Both are subsidiaries of SMC.

"We follow scientific processes committed to integrity.
... Give us one week I have to follow due process but I want to tell you my heart is for you," Lopez told the processers. The DENR had earlie or dered the plants to stop dumping ash on the shared stockpile.

Derek Cabe, of the Nuclear-Free Bataan Movement and the Coal-Free Central Luzon, who has been coordinating closely with the affected communities said the "best-seller" medicines of local drugsfores were for respiratory allments.



# DENR rejects Coron, Palawan underwater theme park project

he Department of Environment and Natural Resources (DENR) yesterday said it will not allow the establishment of the 400-hectare underwater resort and theme park being proposed by an American children's television network off Coron, Palawan."

DENR Secretary Gina Lopez stressed that she will not permit the construction of Nickelodeon's proposed development off the waters of Coron, Palawan.

Lopez said she would not allow it even as the network promised to protect the ocean and conserve coral reefs.

"If it entails the destruction of corals, right away I'll say 'no way.' Fishes need corals. The corals are home of the fishes. And some of the corals have shells and sponges that could cure cancer," she explained.

"I would never allow our biodiversity to be killed for the money some people want to make. The Filipino people are much more important, and will always be more important than any business," the environment chief stressed.

In a related development, the Department of Tourism (DOT) said it will reach out to the parties involved in the planned project.

"The underwater park being planned by Nickelodeon has reached us at the DOT.... We will talk to all parties involved in the project," works, Nickelodeon's parent company, in a statement sent to AFP Tuesday announced it will build an underwater resort and theme park on an island in Coron which they said aimed to giving the fans a chance to "interact with the brand and the iconic characters they love."

Ron Johnson, executive vice president of Viacom, said they chose Palawan because it "is known to have some of the most beautiful beaches in the world today."

The Save Philippine Seas group initiated an online petition, which, to date had gathered more than 160,000 signatures.

"Honestly, Coron is already beautiful in its natural state," De Castro stated.

In 2016, Palawan topped the New Yorkbased magazine Travel + Leisure's list of World's Best Islands.

Travel + Leisure based the list on the results of its annual survey where it asked the readers rate destinations all over the world.

The participants rate the places according to their activities, sights, natural attractions, beaches, food, friendliness and overall value.

## DENR firm on stand against Coral World Palawan resort project

The Department of Environment and Natural Resources (DENR) stood by its position that local and foreign tourists will still flock around Coron, Palawan, one of the most beautiful islands in the Philippines, sans the presence of American children's television network Nickelodeon in the province.

This, after Coral World Park Undersea Resorts, Inc. confirmed on Thursday that it will indeed develop resort in the area while denying that it will be an underwater development.

To build the resort, Coral World will partner with Viacom International Media Networks (VIMN), a unit of Nasdaq-listed media company Viacom, Inc., the company behind multimedia entertainment brands such as MTV, Nickelodeon, Comedy Central and Paramount Channel.

DENR Undersecretary for Legal Affairs Maria Paz Luna said in aftext message that the agency is yet to receive any application from the joint venture.

"We can't pre-empt a decision on this until we see what they are proposing. But suffice it to say that generally for now our natural wonders are already there to see The secretary is inclined to have the people on site benefit from any interventions but ruining natural environments to highlight nature will not work. Paz toid Business Bulletine

Bulletin:
"No application here yet so I cannot speculate; hence, general principles is all I can share with you. Proponents cannot ruin natural environments to highlight nature. Ecosystem disruptions to teach ecosystems will be denied," she added.

In a statement, Coral World Park Marketing & Communications Director Susan Lee said "there will be no theme park development in Palawan" only a "resort and attraction of which we are designing as an undersea attraction with an ocean conservation focus."

Palawan is now home to two UNESCO world Heritage listed sites, a subterranean river and the Tubbatahalcoral reefs.

"I will never allow our biodiversity to be killed for money that some people want to make," Environment Secretary Gina Lopez said on Thursday.

An official of resort developer Coral World Park Undersea Resorts Inc. clarified yesterday that the firm would not build a huge underwater theme park in Coron, Palawan.

Susan Lee, marketing and communications director of Coral World Park (CWP), said, "There has never been any form of By RHODINA VILLANUEVA

communication from our side mentioning a theme park. Our plan is to build a resort and attraction; of which we are designing it as an undersea attraction with an ocean conservation focus."

"There will be no theme park development in Palawan," she added. CWP noted that the "undersea" themed "park is land-based but is designed to meet the international standards regimed as a global destination especially environment-related standards advocating conservation to instruction renewable energy and Category 5-proof

architecture.

The developer also slammed news wire agency Agence France Presse, saying it did not clearly reflect the full details of the announcement of Coral World Park and Nickelodeon-owner Viacom International Media Networks.

After the announcement, several online petitions against the plan were launched by various environmental

Palawan is home to more than 300 coral species or about half of all coral species in the world, as well as breeding ground of more than 1,500 fish species in the country.

CWP also clarified reports that a full 400 hectares are to be developed under water, saying this is inaccurate.

The firm pointed out that "only 100 hectares have been allocated for the Nickelodeon facility and up to 30 hectares is allocated for the attraction itself and "not 400 hectares" as indicated in earlier reports. And that this has not been finalized yet," Lee said.

"The only infrastructure to be built in the water is floating, and all developments are on land. The undersea themed Coral World Park project is land based but is designed to meet international standards required as a global destination," read the CWP statement.

"The facility will be built on a private property and will be undergoing all the necessary approvals from government before construction starts. The Coral World Park owns eight global brands for "Within the parameters set by our founders, we have our own strict adherence to the environment. We aim to create a large-scale reef conservation program that is sustainable, together with sanctuaries for key species in the area. "We take the petitions seriously, but sad to say, information has been misunderstood. We hope these points clarify all matters concerning this development," Lee said.

Environment Secretary Regina Paz L. Lopez, reacting to reports of the proposed "underwater theme park," said she would not allow such destructive project to happen.

Environmental groups also issued strong statements opposing the project, branding the project proponents claim of advocating ocean protection and coral-reef restoration as nothing but "greenwashing".

AA Yaptinchay of the Marine Wildlife Watch of the Philippines and Gloria Estenzo Ramos of Oceana Philippines lamented that such development—if constructed in marine or coastal areas will definitely cause adverse impact to the marine and coastal ecosystem and marine wildlife. An online petition launched by enwironmental advocates mixing the proposed underwater theme park in Palawan gathered 100,000 signatures within the first 24 hours, with some of the signatories citing as reason that the plan would cause massive damage to marine and coastal areas.

Meanwhile, in an official statement, Lopez said if the project would cause the destruction of corals, she would reject the proposal.

"The fishermen need corals. The corals are the home for the fish, and some of our corals have shells and sponges that can cure cancer. I will never allow our biodiversity to be killed for money that some people want to make," she said.

Lopez said the Philippines is a country of 7,000 islands, which has the highest endemism per unit area in the entire world.

"Palawan is the No. 1 island destination in the planet. It has rich biodiversity and lots of ecotourism potentials that should be primarily tapped by Filipino people for the Filipino people," the official said.

An environmental advocate, Lopez said, whatever decision the DENR will make "shall be filtered and anchored on social justice" and will benefit the greater majority.

# Atienza joins fray to oppose construction of underwater theme park in Palawan

A former secretary of the Department of Environment and Natural Resources (DENR), now a member of the House of Representatives, joined the growing number of Filipinos opposing the construction of a 400-hectare underwater theme park in Palawan, saying the disadvantage brought about by the destruction of the country's remaining coral reef far outweighs the benefits the proposed theme park would bring.

"The country's remaining coral reefs now stand at five percent. And to allow the construction of such underwater theme park will totally destroy whatever is left of our coral reef. It will be driven to extinction," Senior Deputy Minority Leader,

Buhay Rep. Lito Atienza told the Tribune in a telephone interview.

Early this week, it was reported that American children's television network Nickelodeon is planning to build underwater resort and theme park in Palawan, which would form part of the 400-hectare undersea development in Palawan.

"No amount of assurance coming from the proponents the project would promote environmental protection could convince us that the proposed underwater park will not destroy the fragile marine environment and aquatic life in Palawan," said Atienza, who was DENR secretary during the time of former President and now House Deputy Speaker Gloria Macapagal Arroyo.

"I support the position of DENR Secretary Gina Lopez not to allow the construction of the underwater theme park," Atienza said.

House natural resources committee chairman and Bayan Muna Rep. Carlos Zarate also hit the proposal of Viacom International Media Networks, in collaboration with underwater resort developer Coral World Park Undersea Resorts Inc., to develop a Nickelodeon Resort and Attraction in Coron, Palawan.

The 400 hectare undersea themed park, expected to be finished by the year 2020, will supposedly feature restaurants and lounges six meters below sea level:

"The construction of such an immense commercial establishment in Coron will clearly disrupt the ecosystem and biodiversity of the place," said Zarate as he recalled that since 1967, through Proclamation

219, the unique ecological features of Coron Island and its surrounding islets have already been recognized.

Subsequently, Proclamation 1801 and Proclamation 212 further reinforced its protection as a marine habitat and forest reserve.

# Vational Greening Program created

## 3.3 million jobs in 6 years

THE National Greening Program (NGP) generated about 3.3 million jobs in the first six years of its implementation, but continued to miss its target survival rate for planted seedlings, the Philippine Institute for Development Studies (PIDS) said.

"As of Nov. 30, 2016, the program has generated approximately 3.3 million jobs and employed 462,066 persons in upland and rural communities," PIDS said in a policy note.

In "Taking stock of the National Greening Program six years hence," PIDS said employment generated by the NGP increased from 2011-2014, slowing down slightly in 2015 and stagnated last year.

"The data revealed that the employment performance of the NGP may have significantly decreased in 2016 relative to its performance in the past years," said PIDS.

Meanwhile, the program continued to miss its target survival rates for seedlings planted in 2011-2015.

According to the PIDS, the survival rate of seedlings was only 83% in 2011-2014 and only 82%

"While the program targets an annual survival rate of 85%, the actual figures have remained below it. From 2011 to 2015, for instance, the annual survival rate nationally has been 83% except in 2015 when the program registered a survival rate of 82%," the think tank said

However, according to PIDS, the NGP will result in "favorable and increasing output effects in the economy" over the years. Output is expected to increase

0.3% in 2020, 1% in 2030 and 2.5% in 2050 with forestry expected to reach as high as 5.5% of the total NGP output in 2050.

NGP also has the potential to increase household income and decrease poverty.

"The income effects are progressive, with the lowest decile having real household income improvement of 1.4% in 2030 and 3.3% in 2050, while the highest decile having positive real income

effects of 1.2% in 2030 and 3.0% in 2050," said PIDS, adding that poverty incidence will decrease 2.7% in 2030 and 6.34% in 2050.

While PIDS observed positive effects of the NGP on the environment, the design and tree species planted by the NGP are not always appropriate to the sites.

"These fast-growing (softwood) species may have been intended to help the people's organizations earn money in the shortest possible time and address their income and poverty concerns. However, on the environmental side, these species may be of less help as they are shallow rooted and vulnerable to landslides," said PIDS.

PIDS therefore proposes that the national government review the design of the program in terms of species planted, tree spacing and other technical matters.

The Department of Environment and Natural Resources (DENR) must also identify vulnerable areas in its mapping and planning stage in order to match species with sites.

PIDS also recommends that the government revisit its computation of the survival rate and other technical aspects in monitoring the program.

Additional incentives such as harvesting rights, livelihood support; long-term financing and correction of tenure issues must

be provided to communities to sustain plantations in the long-

PIDS also suggests additional funds for organizational development and capacity building of the people's organizations as well as strengthen the DENR to effectively carry out reforestation and rehabilitation.

"The national government should place the ultimate responsibility for all reforestation initiatives on the FMB (Forest Management Bureau)... Alternatively, the creation of a new agency tasked only with reforestation, possibly answering directly to the president, should be considered," said PIDS. – Danica M. Uy

Governor Imee Marcos on Thursday said the province is concerned by possible health hazards from coal waste as well as environmental consequences.

"This is the reason why we are intensifying our commitment to a coal-free Ilocos Norte," Marcos said.

Earlier, the provincial government

passed Resolution No. 017-2016, which declared Ilocos Norte as "clean, green and coal-free" and highlighting the province as "the undisputed wind energy capital of. the Philippines."

Marcos said their initiative for a coal-free province is also in support of the national government's commitment to the United dress, she said, "As a province of farmers,

Nations Framework Convention on Climate Change (UNFCC) to reduce carbon emissions from expected levels in 2030.

"Our vision for a 'livable, sustainable, and resilient' province, promotion of renewable energy and proper care of the environment has risen among our priorities in the province," she added.

The governor said the provincial government's vision includes the rejection of energy development using coal of any type.

This is due to proven harmful effects [of coal] on the environment, impact on climate change and health menace to the people," Marcos added.

In her 2016 State of the Province Ad-

ecological sustainability comes indeed naturally, but we have begun to take for granted even our environment.".

Ilocos Norte is host to the Energy Development Corporation's (EDC) 150-megawatt Burgos Wind Power Project, the Northern Luzon UPC Asia Corporation's 81MW Caparispisan Wind Power Station and the Northwind Power and Development Corporation's 52MW Bangui Wind Power Project.

Recently constructed were the 5MW Agua Grande hydroelectric power plant in Pagudpud town and solar farms—the 20MW facility of Soleg Philippines Inc. and the A.1MW and 2.6MW facilities of the EDC.

Meanwhile, the provincial government

is forming a task force to review the province's environment code and to incorporate stricter measures against coal energy.


Marcos said there is a need to reinforce ordinances and resolutions in support of provincial programs concerning the environment.





The provincial government of Lanao del Sur has created the Lanao Basin Management Council to ensure proper planning and implementation of the Integrated Natural Resources and Environment Management Project or INREMP for the Lake Lanao River Basin.

Meeting with the Department of Environment and Natural Resources and different local government units on Tuesday, the provincial government created programs and a roadmap for the river basin's development.

Under INREMP, \$100 million (P5 billion) from Asian Development Bank and 13.25 million in Special Drawing Rights from the International Fund for Agriculture Development—worth about P884 million—will be used to bankroll the program.

Lake Lanao is in Lanao del Sur, covers 340 square kilometers and is the largest lake in Mindanao, the second largest in the Philippines, and is one of the 15 "ancient lakes" in the world "Its used to be the sole source of power of Mindanao through hydroelectricity, now it provides roughly 30 percent of the region's energy, officials said.



#### Nickel Asia says ore shipments fall in 2016

NICKEL ASIA Corp. on Thursday said shipments of nickel ore dropped 2% in 2016 amid lower volumes 1 and lackluster world prices.

In a statement, the listed miner said it sold 19.3 million wet metric tons (WMT) of nickel ofe last year, slightly lower than the 19.7 million WMT of shipments: recorded in 2015.

"Lower shipment volumes coupled with the overall weakness in nickel ore prices led to a drop in the Company's estimated value of shipments from P14.4 billion in 2015 to P13.3 billion in 2016;" " Nickel Asia said.

Nickel Asia noted the estimated realized nickel prices on 11.7 million WMT of ore sales, mainly to Japanese and Chinese customers, last year averaged \$20.82 per WMT. This compares with an average of \$22.64 per WMT in 2015.

Of its four operational mines, the Taganito highpressure acid leachate (HPAL) facility accounted for the bulk or 42% of total shipments: In 2016, the mine shipped 2.3 million WMT of saprolite ore, 8% lower than the 2.5 million WMT in 2015. It also shipped 5.7 million WMT of limonite ore for the full year, 10% up from 5.2 million WMT in 2015.

Meanwhile, the Rio Tuba mine accounted for 32% of the total shipments. Broken down, this consists of 2.3 million WMT of saprolite ore and 3.9 million WMT of limonite ore.

Shipments from the Hinatuan mine during this period fell 6% to 3 million WMT in 2016, from 3.2 million WMT in 2015, while its Cagdianao mine shipped 2.1 million WMT in 2016 from 2.2 million WMT in the prior year.

"The unfavorable weather conditions and the effects of sea swells during the first half of the year resulted to delays in the start of shipments from the Company's Hinatuan and Cagdianao mines, thereby translating to slightly lower shipment volumes in 2016." Nickel Asia said.

Shares of Nickel Asia remained unchanged on Thursday to close P8.49 apiece. — J.C. Lim

## Nickel Asia 2016 exports down 2%

NICKEL Asia Corp. (NAC) yesterday announced that it exported 19.3 million wet metric tons of nickel ore last year, down two percent from the previous year's total of 19.7 million WMT.

NAC also expressed that lower shipment volumes coupled with the overall weakness in nickel ore prices led to a 7.6 percent drop in the company's estimated value of shipments from P14.4 billion in 2015 to P13.3 billion in 2016.

The company also stated that the estimated realized nickel price on 11.7 million WMT of ore sold mainly to Japanese and Chinese customers in 2016 also averaged \$20.82 per WMT compared to an average of \$22.64 per WMT realized in 2015.

NAC also realized an average of \$4.39 per pound of payable nickel on 7.6 million WMT sold in 2016, down from the average price of \$5.36 per pound of payable nickel

on 7.8 million WMT sold in 2015.

The company attributed the lower volumes due to remedial work conducted over a one month period at the Taganito HPAL plant, which reduced ore delivery. The work was completed in May 2016 and the plant has since resumed operations at full capacity.

"The year 2016 was challenging as we saw nickel prices hit a 13-year low early in the first half, a continuation of the downtrend that we experienced in 2015. However, prices in the second half have improved in line with improving fundamentals for nickel due to declining inventories coupled with some production cut-backs and closures, and a strong recovery in the Chinese stainless steel market. All these suggests higher nickel prices this year," NAC president and chief executive officer, Gerard Brimo said in a statement.
