accept that this is very small and narrow-minded of me, but I must say that I would rather be in the Philippines contending with a narcissistic-personalitydisordered man like Rodrigo Duterte than in the United States contending with a narcissistic-personality-disordered man like Donald Trump. What are the odds of the two countries electing similarly afflicted personalities? I cannot venture to say.

It is a close call, but in the end, Trump

loses. How or why? Read on.

First, on the choice of Cabinet members and advisers. This is where Mr. Duterte appears to be better than Trump. Of course, there are cases where it is close, as, for example, his choice of justice secretary compared with Trump's choice of attorney general (the rough US equivalent). Sen. Jeff Sessions, the nominee, reportedly has "a nasty civil rights record" and has been "dogged by claims of racism and bigotry throughout his career." His "history and present positions make it undeniably clear that he cannot be entrusted to uphold equal justice, civil rights, or the right to vote. Wows

of Trump has exposed himself to charges of nepotism, with the appointment of his son-in-law as senior adviser. Mr. Duterte's two sons and daughter are nowhere in sight as far as positions in his administra-

tion are concerned. Good. Further, his choices have not met with nearly as much criticism as Trump's choices (especially from civil society, since the Democrats seem to have lost their tongues... Does that sound familiar?). And rightly so. I agree with those who think that Mr. Duterte's

choices (especially of the Cabinet members) who deal with the economy and social justice) are the saving grace of this administration and

Take, for another example, Trump's, choice of Scott Pruitt as administrator of the Environmental Protection Agency (EPA), Pruitt is considered a "climate change denier" and does not seem to believe in global warming or its effects. Plus he has sued the EPA on its Clean Power Plan and on its regulations on methane emissions: And Trump chooses him to be EPA administrator. Good grief. Contrast that with Mr. Duterte's appointment of Gina Lopez as environment secretary. See the difference?

Next, let's talk about their relations with the media. Both men have at some point accused the media of biased or false reporting. And Mr. Duterte has been known to be boor-ish and insulting to the media. But he has accommodated reporters, and never followed up on his threats to limit his accessibility. Trump, on the other hand, is extremely

reluctant to meet with the media, relying mostly on tweets and such social media devices (no face-to-face interaction). And when he finally met with reporters, he refused to answer questions from CNN's senior correspondent Jim Acosta, and his press secretary threatened to have Acosta ejected if he per sisted in asking questions. I don't think Mr. Duterte has done that. Point for him.

The third point of comparison has to do with their exaggerations, their outrageous statements, their lashing out at others, which, experts say, are an indication of the

personality disorder.

Mr. Duterte has lashed out at Sen. Leila de Lima, calling her the Philippines drug queen, or words to that effect. De Lima's error? When she was chair of the Commission on Human Rights, she called him to task for the Davao Death Squad activities (which he had publicly admitted, by the way, as he had admitted to various killings).

Trump's latest lashing out is at Meryl Streep, whom he called "one of the most overlated actresses in Hollywood"—which shows now disordered people can totally ignorestates inomaking their conclusions. Streep has been nominated for and has won more Academy Awards than any other actress plus Cannes Film Festival awards, Emmys, and Golden Globe Awards She has been called, by experts, as the "best actress of her generation." Overrated?

What was Streep's "sin"? She called him to task for using his power and posi-

tion to bully others.

But isn't that what Mr. Duterte does? That's why it is a close call.

Aid agency Japan International Cooperation Agency (Jica) has granted state-run Land Bank of the Philippines (Landbank) a 4.9-billion yen (over P2.1 billion) loan to support the agriculture sector in the wartorn areas of Mindanao.

In a statement, Jica said the official development assistance (ODA) under its yen loan scheme was launched this week through a project dubbed "Harnessing Agribusiness Opportunities through Robust and Vibrant Entrepreneurship Supportive of Peaceful Transformation" or 'Harvest."

The project would be assisting agriculture enterprises as well as farmers' cooperatives, among other related organizations, in Mindanao, Jica said.

It would also provide human resource training and technical assistance to Landbank, agriculture cooperatives, and other relevant institutions, Jica added.

"'Harvest' presents opportunities to help ordinary Filipino farmers in Mindanao and related institutions grow the agriculture sector. Through the project's financial inclusion of farmers' cooperatives, micro, small and medium enterprises (MSMEs), and related organizations, more investments and jobs will be created in Mindanao's conflict-affected areas," Jica chief representative Susumu

Ito said.

Government data showed that in 2013, agriculture, fishing and forestry accounted for over three-fifths of Mindanao's regional economy, employing 68.4 of its population.

Poverty incidence, however, remained at over half of the population due to the decades of conflict in several parts of the island, Jica noted.

The Japanese aid agency and the Bangsamoro Development Agency had worked on the proposed Bangsamoro Development Plan (BDP) 2, the medium- to long-term plan that will guide development in Mindanao.

Jica had been wanting to help roll out under the BDP 2 a total of 26 anchor projects spanning a wide array of socioeconomic sectors in order to lift Bangsamoro' people out of poverty by 2028.

If fully implemented, the BDP 2 would create about 550,000 additional jobs by 2022, while the region's economy could grow as fast as 7.4 percent annually, according to Jica.

The anchor projects earlier identified by Jica and BDA under the BDP 2 were as follows: support for agricultural cooperatives; road rehabilitation and upgrading; ports and airport improvement; Greater Cotabato City urban infrastructure; communal irrigation; economic corridor development; economic zones; as well as abaca, coco coir and sugar industrial clus- from 2003 to 2015, it added. INQ

ter development.

Also among the BDP 2 initiatives were agri-based projects (such as goat farming and mixed field crop production); seed production center; halal industry promotion; open market; cold chain facili-ties; community-based forest and coastal management; mini hydropower development; and Mindanao river basin integrated watershed as well as flood management projects.

A 2005 study of the Human Develop ment Network noted that the underdevelopment of the Autonomous Region in Muslim Mindanao (ARMM) is linked to the long history of armed conflict in the area. According to the said report, the war in Mindanao costs around P5 to 75 billion annually, which could have been used instead to fund development projects

The poverty incidence in ARMMewas at 55.8 percent in 2012—much higher than. the national average of 25.2 percent and 39.1 percent for the whole of Mindanao. government data showed.

Since 2002, Jica has been extending assistance to about 30 programs and projects in Mindanao under the Japan-Bangsamoro Initiatives for Reconstruc-tion and Development or J-Bird.

A total of 20 billion yen in develop ment aid has been provided by Jica as well as Japan's Ministry of Foreign Affairs

Rody gov't gets top marks on 11 of 12 nat'l issues

The Duterte administration enjoyed majority approval ratexcept for the issue of controlling inflation, Pulse Asia said in its fourth quarter survey.

Most Filipinos remained appreciative of the government's handling of criminality (84 percent), disaster response

(80 percent), corruption (76 percent), OFW welfare (75 ings on key national concerns, percent), peace (72 percent), environment (69 percent), rule of law (69 percent), territorial defense (65 percent), jobs (58 percent), workers' pay (57 percent) and poverty (51 percent)... The government, however,

failed to obtain a majority approval score on the issue of controlling inflation - considered urgent by 34 percent of Filipinos

– which was only at 44 percent.

According to Pulse Asia, the only sig-

nificant movements during the period were the decline in approval ratings for administration efforts to increase the pay of workers (-7 percentage points), control inflation (-7 percentage points) and reduce

poverty (-8 percentage points).

"For the most part, public assessment of the administration's performance remains constant between September and

December 2016," it said.

The survey was conducted from Dec. 6 to 11, using face-to-face interviews with 1,200 adults.

It has an error margin of plus or minus three percentage points at the 95 percent confidence level - Helen Flores



Fake

Fake news is usually associated with the prevalence of social media.

In that ungoverned space, it is easy for the unscrupulous or the reckless to pass on fake news. In this space, there is no editorial supervision to ensure truthfulness. It is easy to spread false information under the cover of anonymity. This



But how do we explain the infiltration of fake news into the mainstream media?

Take the case of the supposed coal ash adversely affecting residents in Limay, Bataan. The town is the site of the sprawling state-of-the-art refinery facility of Petron Corporation. A power plant is also located in the facility.

One broadcast organization broke the news that residents in the vicinity of the "coal plant" were suffering from skin diseases because of the ash pile. Environmental groups, always primed to demonize big corporations, picked up the story and began organizing pocket protest actions.

As soon as the story broke, San Miguel Corporation president Ramon Ang dispatched a team by helicopter to Limay to find out what was happening. He was sure this was fake news. When all the facts were gathered, Ang himself faced the media to dispute the broadcast account.

Firstly, said Ang, this could not possibly be a coal spill. There is no coal in the entire complex. The power plant under construction is being test run using diesel fuel. That plant will not be operational until next year.

The video carried by the broadcast group was not coal ash as claimed. It is limestone powder, a by-product of oil refining certified by the DENR as non-toxic. The broadcasters did not bother to correct this.

Furthermore, the limestone powder is not "dumped" as the television station claimed. It is stored in a specifically constructed ash pond surrounded by dikes far away from the river. No river pollution happened.

far away from the river. No river pollution happened. Were it not for the refusal of the local government to permit transport of the limestone powder to a sister company producing cement the limestone powder would have been trucked out. The powder is valuable commodity. It is worth \$100 per ton when transported for use as cement.

Local health officials, meanwhile attested that the skin rashes affecting residents close to the complex was actually scabies. It cannot be attributed to limestone powder but to tick bites and infected domestic animals.

DENR Secretary Gina Lopez, based on the fake news, initially wanted to impose a cease and desist order on the Limay plant. After being briefed by Ang himself, she immediately issued a permit for Petron to transport the limestone powder to the cement plant. She was also briefed on Petron's programs to care for the communities surrounding the facility.

In the end, there was really no basis for the alarm caused by irresponsible reporting.

Dead pangolins, seahorses seized from ship in Manila

he Philippine Coast Guard on Friday found a truck loaded with dead and preserved pangolins, seahorses and other wildlife aboard a ship docked at Manila North Harbor's Pier'4:

Smuggled dried seahorses seized

The Philippine Coast Guard (PCG) confiscated early yesterday morning large quantity of dried seahorses on board a vessel in North Harbor, Manila.

PCG spokesman Commander Armand Balilo said boxes of the smuggled marine species were found inside MV St. Francis Xavier docked at Pier 4, North Harbor, at around 3 a.m.

He said the vessel, plying the Iloilo/Bacolod – Manila route, is owned and operated by 2GO Group Inc.

Upon docking at 2:56 a.m., the search team composed of Coast Guard Station (CGS) Manila, PCG K-9 unit, Sea Marshal Group (SMG), and the Philippine Air Force (PAF) Intelligence Unit boarded the vessel and located a 10-wheeler truck where they discovered the dried sea horses.

The truck's contents were originally declared in the cargo manifest as scrap plastics.

The team also discovered other cargoes onboard they also suspect to contain other endangered species.

PCG, as of press time, was still inspecting the other cargoes.

Representatives from the De-

partment of Natural Resources (DENR) also arrived at Pier 4 to examine and identify the other seized smuggled marine species. Balilo said the PCG will file appropriate cases against the shipper of the cargo. (Argyl! Cyrus B. Geducos)

PM Abe to adopt PH Eagle

DAVAO CITY – Prime Minister Shinzo Abe will be adopting one of the Philippine Eagles which is under the care of the Philippine Eagle Foundation, according to sources from the nonprofit group.

Dennis Salvador, executive director of the PEF, said the agency is hoping for improved partnerships between the foundation and its Japanese counterparts for further research efforts especially with endangered raptors such as the one in captivity in Davao City.

The PEF is a nonprofit organization in charge of the care of endangered species such as the Philippine Eagle, at its facility in Malagos, Davao City.

According to Salvador, the eagle was captured in the Pantaron Range in Talaingod, Davao del Norte, last December after being found limping in the forest.

The eagle could not fly and had a pellet gun wound in the groin.

However the eagle won't be at the ceremonial naming with Prime Minister Abe and President Rodrigo Duterte, as it is still recovering in the facility.

At the moment, conservation efforts of the PEF are mostly voluntary, with the academe and the private sector taking the lead.

There are 36 Philippine Eagles at the PEF facility in Malagos, with each of the eagles already adopted by a benefactor.

Each eagle costs around ₱125,000 (¥289,600) in terms of upkeep per year.

Salvador clarified that the ceremonial naming involved mostly a goodwill message with no talks yet of the financial aspect of the adoption of the eagle.

The eagle will be named "Sakura," after the popular Japanese flower which blossoms once a year. (Yas D. Ocampo)

Davao City, Biliran mining free-zones

A PANEL in the House of Representatives has approved measures declaring Davao City and Biliran province as mining-free zones to protect their local residents and the environment from the adverse effects of mining.

The House committee on natural resources, chaired by Bayan Muna party-list Rep. Carlos Isagani Zarate, passed House Bills 3166 and 872, declaring Davao City and Biliran Province, respectively, as mining-free zones.

The bills recognize the constitutional provision which states that "it is the policy of the State to protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature."

Davao Rep. Alberto Ungab, author of HB 3166, or "An Act. Declaring the City of Davao as a Mining-Free Zone," explained that "if one and to mining on that "if opened to mining op-erations, a world-class city like Davao City would unnecessarily be endangered by deforestation and the risks attributed to mining since the place is traversed by Davao River from the highlands to the lowlands."

Ungab said the fresh waters of Davao City, considered as one of the best waters in the world, must be protected from any form of pollution or degradation, to include the surroundings and environs of its sources underneath the ground or above the ground.

URBAN PLANNERS' PRESENCE A MUST IN EVERY DEVELOPMENT

reating livable and sustainable communities entails more than the use of high grade bricks and mortars.

Every developer knows that

Every developer knows that for a project to be truly successful, there should be proper planning involved.

It may be tempting sometimes to take short cuts and deviate from the tedious method of planning for a particular development, but no trustworthy developer would do such thing.

As such, every responsible developer understands the significance of employing the services of urban planners to ensure that every project will not harm the environment and will benefit not only those living within the community but also those within neighboring areas.

Professional designers

"Urban planners are professional designers of a town, a city, a region or even a community. They give these places a face or an identity," explained Arch. Ma. Karmela Bayot, an inhouse master planner for Sta. Lucia Land Inc. (SLLI).

A graduate of BS Architecture at the Pamantasan ng Lungsod ng Maynila, Bayot explained to Inquirer Property about the crucial role that an urban planner plays in the success of every development.

According to Bayot, the holistic approach for the development of a community is usually based on the urban planner's design and programs.

"We are the macro designers who would dictate the land use and transportation plan of a developer's projects. We are the first to be on the site to analyze and study an area's physical condition and its potential for development," Bayot related.

An urban planner's work can in fact go beyond the design, and extend to the study of

the socio-economic profile of a certain town. It is normally the urban planners who suggest the possible jobs that can be offered to the community.

"We cannot force business process outsourcing related projects if the population is used to fishing or farming. We need to determine how to make the best use of available spaces and the how else can we revitalize the area," Bayot noted.

Enhancing environment

According to Bayot, urban planning has long been a part of real estate development in the Philippines.

"Even before the real estate industry started to develop subdivisions, urban planning already exists in the country. In the history of urban planning, architects, engineers and even scientists have become urban planners or masterplanners because of their ideas to enhance the living environment and in-

troduce innovations to their town or their city," she said.

Master planning referred to the fundamental stage of design development. It covers the study of the slope, terrain, and orientation, and puts into consideration the existing facilities and natural environment.

"Planting trees, providing open spaces having the proper width of sidewalks for convenience, ensuring the right locations of loading and unloading docks, and respecting natural resources like rivers and creeks and the hundred old trees, are just among the primary considerations of an urban planner," she further explained.

Indeed, urban planners must have a presence in every development. And while it is true that a developer can still implement a project without an turban planner, there is that risk that it can fail due to lack of proper study

proper study
"We all aim to provide a better community. Other than the physical design, I believe we have the social responsibility not only to our clients but to the community as well," Bayot said.

Building a character

Creating a community, according to Bayot, is like building the character of the people who will live there.

"If we could only apply these to all the future developments, we may be able to revitalize our city and even avoid man-made calamities," she claimed.




Urban Manner's Presence A Must in Every Devit.

In the Philippines, much has yet to be done when it comes to urban planning, as evident in the massive damage. wrought by strong typhoons in certain areas that may be considered as "no plan cities".

"The congestion of the metro has brought butterfly effect. From overcrowding, traffic, shortage of job opportunities and even crimes. When people started to ask whose responsibility should it be that was when urban planners became known," Bayot added.

In the country, one developer knows all too well the importance of having an urban planner on board—trusted property developer Sta. Lucia Land Inc.

According to Bayot, she was hired in 2005 by Sta. Lucia Realty Inc. as a planning consultant. But even before she came on board, there were already others who have taken on the tasks of an urban planner. It was in 2013 that Bayot became an inhouse planner for the company.

"Hiring or getting a professional planner for Sta. Lucia has been their practice ever since," Bayot concluded.

Trouble brews over land dispute

in former friar estate

ANOTHER dispute is brewing in what used to be known as Hacienda de San Pedro de Tunasan in Laguna with residents urging San Pedro City Mayor Lourdes Cataquiz to investigate several armed men who claimed to be her men and are harassing residents of the area.

Community resident Levi Lobo Jr. made the appeal after several armed men, who claimed to be Cataquiz' men, entered the area brandishing their guns and started harassing residents.

"We don't know the mayor's interest in the talks over these lands but

many are wondering why these men are claiming to be from the office of

the mayor," Lobo said in Filipino.

Lobo said the men repeatedly entered the area and appear to be intent on sowing fear among residents with some of them firing their rifles armed

with grenade launchers.
On Jan. 5, Lobo said the men fired their rifles at a group of male residents. On Jan. 9, they again fired their weapons and even fired three grenades to scare residents,

Lobo said residents suspect that the harassment may be connected to the decades-long dispute over what used to be known as the Hacienda de San

Pedro de Tunsan, which used to be owned by the Society of Jesus.

Various lawsuits have arisen from the hacienda which was "awarded" to Spanish conquistador Esteban Rodriguez Figueroa, a one-time governor of Mindanao, in the 16th century.

Rodriguez bequeathed the hacienda to the Order of Saint Augustine and later transferred to the Society of Jesus for the establishment of the Colegio de San Jose.

The hacienda was later transferred

to the Colegio de San Jose, which is now known as the San Jose Seminary. However, the hacienda was transferred to the Agustinian and Dominican orders after the expulsion of the Society of Jesus from Spanish possessions in the 18th century.

In the following century, ownership of the land shifted from the Catholic Church and the government along with various third parties who also laid claim to portions of the hacienda in partnership with the church or the government.

One of such private parties was Carlos Young, a registered owner under Original Certificate of Title No. 656 and Transfer Certificate of Title No. 166689, who was in partnership with Colegio de San Jose in the 1930s.

Young apparently agreed to donate to a portion of the land to the then Municipality of San Pedro in exchange for a waiver over accumu-

lated property taxes.

However, Young later discovered that the parcel he agreed to donate to the town was being claimed by one Oliver Laperal, who presented land titles that was later found to cover lands in Taytay, Rizal.
