Duterte to review closure of min

President Duterte said on Friday night that he would review the decisions of Environment Secretary Gina Lopez, as he acknowledged the controversy they have stirred up.

But Mr. Duterte said he was withholding judgment on Lopez, adding that there was nothing he could do about her decision if the companies involved were really destroying the environment.

Mining firms are up in arms, sin a speech during dinner where Lopez's decision to order. Philippine Military Academy over Lopez's decision to order the closure of 23 mines and to scrap 75 mining contracts for covering watershed areas.

Administrative remedies

According to the President, there were administrative remedies that the mining firms could take.

"But I will, I will review. There's such a thing as exhaustion, for the lawyers, exhaustion of administrative remedies, I will not judge her now," he said

alumni on Friday.

But if the companies were destroying the environment, there was nothing he could do.

"I will look at it. But if it's in the wrong, there's nothing I could do, if it's destructive to the environment, he said

But Mr. Duterte also said he would take into account the revenue brought in by mining operations.

"We get something like P70 billion a year out of the min-

ing operations in the entire Philippines. So we have to also take [that] into consideration,"

Lopez , earlier said she scrapped 75 mineral production sharing agreements because the projects were located in watershed areas.

On the other hand, the closure of 23 mines came after an audit by the Department of Environment and Natural Resources, which found that they had engaged in indiscriminate mining and ruined watershed areas.

The mining companies had hit back on the closure orders, saying they had not been given copies of the audit results. They also warned that many Filipinos stand to lose their jobs.

In protesting the cancella-tion of the mining contracts, they raised the government's responsibility to uphold con-

tracts and follow due process.

The mining firms are also seeking to block Lopez's confirmation as environment secretary before the Commission on Appointments. . INQ

Billionaire-miners scream, a rare sight in a rich-worshipping country

URS is a country that worships the rich. Whether they are oligarchs or vice lords does not matter. Rich-worship is across-the-board and is not blurred along the source of wealth. Billionaires have a special place of their own: they are regarded as deities. Even the billionaire-miners.

Unlike in other countries, mining in our local context does not stir up a lot of controversies. Even when mine tailings spill into vast swaths of farming communities and cause widespread devastation all around, the state just slaps the mining entities on the wrist. On cases when the holding dams of toxic mining refuse burst into waterways and cause dislocation on a wide scale, the closure orders of the mining firms do not last.

Insofar as mining firms are concerned, it is about multiple chances. There is no such rule as "strike three and you are out."

Ok, that leniency does not cover only the miners. The country's rich bio-diversity is down to less than one million hectares of original timber stand (we call these virgin forest) because of the state's pliable logging policy. How many mahogany courts in the developed world had we supplied with prime hardwood?

All forms of resource-extraction have been regulated with leniency by government.

Today, however, things have changed.

Gina Lopez, the DENR secretary and environmental sheriff of DU30, recently ordered the closure of 23 mining companies, including iconic

names in the mining industry, mining entities that have been with us from time immemorial. Then, in another bold move, she cancelled 75 mining contracts for underdeveloped mines, including the \$5.9 billion Tampakan gold and copper project in South Cotabato. No one in the contemporary history of the DENR has demonstrated the boldness of the new sheriff. She has a powerful argument: life and survival. Reckless mining means death and that should end.

Finally, the DENR gets a spine. And the result is a rare spectacle in this richworshipping country – billionaireminers screaming and asking for support from their perceived allies in the DU30 cabinet. We have not seen this kind of policy implementation before and for those of us in the vulnerable class who used to feel that the billionaires in this country have always been spared from the slightest inconvenience by government policy, we are seeing a rare treat.

The screams of the billionaireminers with closure orders seem to be as primal as the screams of those in the slum communities raided under Oplan Tokhang.

And the new sheriff, Ms. Lopez, seems unfazed, if not revelling in her newfound role as the scourge of the

billionaire class. Ms. Lopez, it has to be pointed out, is the only true blue blood in the DU30 cabinet. She is an heir to the Lopez fortune.

Ms. Lopez is the rare type of blue blood who pushes the Marxists into a great conundrum. Is there really someone from the capitalist class who will work against the interests of the capitalist class? And as we said before, Ms. Lopez is not only doing that -she is having the time of her life doing just that.

The beef of the billionaire-miners is compounded by this fact. Ms. Lopez can be lenient to the miners, too. The review committee she formed to review the state of environmental safety of mining firms in the country offered the usual leniency. The committee, beholden to the old ways and the state's traditional kid-glove treatment of mining firms, recommended two forms of punishment First is fines, big and small fines. The second is suspension of the permits of the viòlators, pending the correction of the violations.

Ms. Lopez went beyond that. She ordered the closure of the more than 20 flagrant violators and suspensions for those with lesser violations. The order on the 75 mining contracts was a virtual death sentence. The power point presentations of Ms. Lopez seem to drive home the point that those closed should remain permanently closed before they inflict more damage on the environment.

A question worth asking in the aftermath of Ms. Lopez's tough policies on the billionaire-miners. Will

she survive the wrath of the miners?

Already, and as expected, the collected wrath of the miners was conveyed to the Commission on Appointments (CA), the bicameral body that screens and approves cabinet appointments of the President

The influential Chamber of Mines of the Philippines, one of the few lobby groups with clout and power in the country, has fired off a passionate opposition to the CA, with a request to junk her confirmation.

The Chamber called her "secretary-designate" which is not normal and which intention is to insult the new sheriff.

Metallurgy and geology students took up parallel actions, which essentially said "No to Gina and Yes to Mina."

The Chamber has everything: money, clout, media muscle, organizational capability, and most of all influence with lawmakers, whether these lawmakers are in the mining communities or not. Remember the fate of Sonny Alvarez? He was pushed out as DENR secretary by some lawmaker -protectors of resource extractors in Mindanao. Poor Sonny had zero chance against the powerful lobby against him.

Is Ms. Lopez tough enough to withstand the tsunami of rage?

That we do not know. But for the spine alone, and doing what has not been done before - which is to inconvenience the billionaire class—many feel she should be defended by DU30. Many secretly want to say this: We are with her.

The party's over

N Valentine's Day, Secretary Gina Lopez of the Department of Environment and Natural Resources (DENR) announced that her department was cancelling 75 MPSAs or Mineral Production Sharing Agreements with min-



ing companies. Many of these projects are only in the exploration stage. The cancellation of MPSAs will not mean the loss of jobs.

But of course the mining companies, the Chamber of Mines of the Philippines (COMP), and pro-mining advocates will not take this sitting down.

The law and watersheds

Many of the questions thrown at the Secretary and her DENR team on that press conference showed a clear bias for the mining companies, where the line of questioning was pretty much stuck on asking about the DENR's authority to make these decisions, and the "scientific" basis of these cancellations.

The answer, at least to me, seemed simple enough. It was about the DENR enforcing the law, which is based on the science that seeks to protect certain areas against environmental abuse and degradation. The answer that the DENR kept repeating was this one: these MPSAs were granted even when these mining projects are in watersheds.

The media would have none of it. Even when the answers from the DENR team were calmly and objectively delivered, even when it was a discussion about the value of watersheds – which is obviously based on science – none of it was being heard.

But reading the Philippine Mining Act of 1995, it is clear even to me that it is based on science, given how it includes a set of rules for protecting the environment against mining projects, given its acknowledgment of the probable/possible adverse effects of mining on the environment – all of which would be based on scientific proof of both.

Section 19 lists down Areas Closed to Mining Operations, and it includes "proclaimed watershed forest reserves" among "other areas expressly prohibited under the National Integrated Protected Area System (NIPAS) or Republic Act 7586. Watersheds are of course part of NIPAS, which makes all watersheds protected areas.

Are 75 cancellations too much?

The pro-mining groups and the Chamber of Mines of the Philippines have insisted that this is too drastic a move, that it is impossible that 75 mining projects are in violation of any law, which would warrant the cancellation of their MPSAs.

Yet this would only be impossible to people who refuse to admit that ultimately, while there is the law and the rule and regulations for acquiring any government permit at all, that where we come from, the acquisition of permits can be as simple as finding the loopholes in the law. It's through those loopholes that the illegal can be made legal, which could explain why there are mining permits for wa-

tersheds, which are protected areas under the law.

In a 2004 report by Earthworks and Oxfam America, a loophole is made more concrete: "One reason that it's difficult to keep mining out of protected areas is that the

boundaries of these areas are often poorly defined. This is a common problem in some parts of the Pacific region, which has relatively few protected areas and many major mines. In the Philippines, for example, mining is prohibited in intact forests and protected areas, yet approximately a third of all mining concessions overlap with these areas. (That figure covers both exploratory and active concessions.)"

In 2006, a fact-finding mission report on the state of mining in the Philippines, which was done by six human rights and environmental groups from the UK, also talked about this overlap and how it endangers the environment, our watersheds, and our communities: "In the Philippines, many mining and exploration concessions overlap watershed areas where demand for water exceeds the available supply. Mining in these areas would therefore be likely to compete with the needs of other users, including farmers and households, for scarce water. Many mining sites are located on mountains that act as watersheds for numerous rivers, potentially compounding the threat."

To me, those 75 cancellations actually finally address the above crises of overlaps between mining contracts and protected areas.

And it's about time.

When Atty. Ipat Luna succinctly and perfectly answered that question about the DENR Secretary's authority to close down the mines and cancel these contracts, by pointing out what is enshrined in the law, there were no follow-up questions, but the badgering of Secretary Lopez continued.

And so it bears repeating. Under Chapter II, Section 8 of the Mining Act: "The Department shall be the primary agency responsible for the conservation, management, development, and proper use of the State's mineral resources including those in reservations, watershed areas, and lands of the public domain."

Can the DENR cancel these 75 MPSAs? Absolutely. From the MPSA itself as published on the Mines and Geosciences Bureau website: "This Agreement terminates or may be terminated for the following causes: <...> (f) any other cause or reason provided under the Act and its implementing rules and regulations, or any other relevant laws and regulations."

The more one watches the mining sector trying to paint itself as victim of DENR and Secretary Lopez, the more one sees how the sector is behaving like a spoiled brat used to getting its way, regardless of the law. And now that the law is being enforced, they cannot even defend themselves and say that what they're doing does not harm the environment and our communities in any way.

Lest they have yet to see the writing on the wall: the party's over.

Thank heavens.

forced revacuation in Agusan del Sur to the destruction brought by logging and mining in the area.

The cancellation of the MPSAs, a preventive measure, aims to protect and conserve the country's fresh-water supply, against the impact of mining operations, Lopez pointed out.

DENR Undersecretary and National Anti-Environmental Crime Task Force Head Arturo Valdez admitted the resurgence of illegal logging activities, and vowed to mount the campaign in so-called illegal logging hot spots.

Executive Order (EO) 23 signed by former President, Benigno S. Aquino III prohibits the cutting and harvesting of trees in natural and residual forests. The logging ban and intensified campaign under the Aquino administration, according to the DENR had reduced the number of illegal logging hot spots from 197. to just 27.

The DENR donated the confiscated hot logs to the Department of Education and were later crafted to make school furniture.

Acknowledging Duterte's order to study the current policy against illegal logging, Lopez vowed there will be "no letup" in the campaign, with Corpuz leading the charge.

Lopez plans to use the budget for the Enhanced National Greening Program to create more green jobs and help would-be affected miners with the impending closure of 23 large-scale metallic mines and suspension of five others, pending a review by the Mining Industry Coordinating Council.

'Condemnation'

MINING industry's big players under the Chamber of Mines of the Philippines (COMP), which has filed an opposition before the Commission on Appointments to block Lopez's confirmation, had

au that 1.2 million people are "condemned to hunger and poverty" with Lopez's actions.

COMP argued that private sector and mining companies have planted the most number of trees over 2 million—in the last five years in support of the government's mas-

sive reforestation program.

It also claimed that mining companies implement progressive rehabilitation in mine sites and tapped local communities in the creation of green jobs and livelihood opportunities.

More PPCPs

MEANWHILE, Tom Valdez, president of Society of Filipino Foresters Inc., said imposing a total log ban will not address illegal logging.

Instead of a total log ban, Valdez said the government should implesaid the government should implement sustainable forest management and allow the private sector to help in the reforestation through the establishment of more forest plantations and public-private-community partnership (PPCP).

Speaking mostly, in Tage log
Valdez, who sits as cochairman of the Interim National Government Board for Establishment of a Phil ippine Forest Certification System, said he supports the massive refor-estation of the country's degraded and denuded forest.

The board, which is composed of representatives from the wood industry, non-governmen-

tal organizations, civil-society organizations, and the Society of Filipino Foresters and concerned national government agencies such as the DENR and the Department of Trade and Industry, is currently organizing and building the capabilities of the wood industry and forestry sector.

He said the people need wood and cutting of trees for fuel alone cannot be stopped by the govern-ment. At the same time, Valdez said the wood industry is already importing more than half of its wood supply to sustain the wood industry

As a forester himself, he added the government has no capacity to protect the country's vast forest and would need the support of the private sector and the community.

Investment

VALDEZ said the government should open up its communitybased forest management (CBFM) areas to private-sector investment, reinforcing the program that will be beneficial to the wood industry, as well as the community.

This will also help lessen the

This will also help lessen the burden on the part of the government in terms of covering more areas for reforestation.

"The government should allow private-sector investment to come in by opening CBFMs. The private companies will invest and provide technical training, while the communities will have jobs. 

ration of a total log ban that will include plantation forests established by the private sector, individuals and NGOs in government lands through the integrated forest management agreements and socialized industrial forest management agreements and CBFMAs.

"For public-sector investment in forest rehabilitation to flow in, we need the private sector and community support. But first, we need an enabling policy environment to build investor confidence," he explained.

Valdez said measures should be enacted by Congress to protect the private-sector investment in forest rehabilitation that will boost forestry contribution to the country's growth and development, and its contribution to the economy in terms of exports, jobs and livelihood opportunities.

He added the country is now import-dependent, and forestry's contribution to the economy, is miniscule. This, he said, is because the country's forest is already denuded, and cutting in natural forests is prohibited under EO/23

"Kasi wala ng cutting. Walang supply. Halos wala. Meron siguro [supply] iyong imported from other countries;" he said.

According to Valdez, forestry's contribution to the economy, will increase, eventually, but this should start with an admission that, in the past, the forests were gravely, abused, and that this time we have the opportunity to bring, it back.

Valdez said the Society of Filipino Foresters and the Philippine Networks of Forestry Schools are developing the sustainable forestry road map—a private-sector initiative.

initiative.
"We will present it in October during a convention in Davao," he said.

For investment in forestry to come in Valdez said, the government should ensure that the policy is stable and that forest certification should be implemented.

Forest certification is now being done, in other countries, he added, and it is high time that the Philippines had its own to ensure buyers that the trees or wood were harvested legally, and in a sustainable manner that does not harm forest ecosystems.

able manner that does not harm forest ecosystems.

With abundant local wood supply and duly certified as coming from environment-friendly sources, demand for illegally logged trees will eventually stop, Valdez said.



As environment officials dismantle fish pens and cages in Laguna de Bay to carry out one of the first marching orders of President Duterte, a fisherfolk organization is asking the gov-ernment. What alternatives are you giving us?

For the alliance, it was "a blanket gorder" that covered even small fish cages as well as structures for kangkong (water spinach) farms.

"The resolution says that no structure will be left standing and all activities would have to cease for one year," the group's spokesperson, Teofilo Mampla-ta, said in a press briefing in Quezon City on Friday.

Mampleta stressed that the

government failed to clarify the processes behind the demolition of the lake structures. "They started without considering the families who rely on the lake for food and livelihood."

24K fishermen affected According to the alliance, around 24,000 small-time fishermen will be affected if all fish pens in the freshwater lake are removed.



toresuland consists of 7.1 million nectares of 24.2 percent of the country's land area.

The Namiria also stated that from 1990 to 2005, the Phillippines lost 32.3 percent of its forest cover or around 3,412,000 hectares.

Legarda said the sustainability of the country's forests is ensuring that both present and future generations would benefit from its

The Quezon City government is now crafting a master plan for the Payatas controlled disposal facility to determine short and long-term development initiatives in the area.

rederika Rentoy, head of city's Environmental Protection and Waste Management Department (EP-WMD), said that the city government is using a seven-hectare engineered sanitary landfill in Payatas for the disposal of solid waste generated by the city. Earlier, the city government appealed to the Department of Environment and Natural Resources (DENR) to reconsider its order calling for the immediate closure of the Payatas sanitary landfill. The city government asked the DENR to give it

sufficient time to prepare for all the vital adjustments to ensure minimal impact on the city's solid waste management system.

The city council has authorized Mayor Herbert Bautista to forge a joint venture agreement with the private sector for the development of the city's own

waste-to-energy plant.

The mayor stressed the need for the establishment of the waste-to-energy plant as it is vital to the city's effort to avert a possible crisis in waste management with the impending closure of the city's sanitary land-fill in Payates. fill in Payata

fill in Payatas.

As provided for under the resolution, the city government shall ensure that the project configuration of the proposed WTE facility is compliant with the required laws and regulations including but not limited to: the Ecological Solid Waste Management Act of 2000; Clean Air Act, Toxic Substances and Hazardous and Nuclear Wastes Act; Renewable Energy Act of 2008 and guidelines governing the establishment and operation of waste to-energy technologies for municipal solid wastes.



和音響 DENR stops hydro power plant development at Mt. Isarog

NAGA CITY—The Department of Environment and National Resources-Environmental Management Bureau - Bicol regional office stopped the site development of the proposed Rangas River Mini-Hydro plant pending review of the Environmental Compliance Certificate (ECC) issued for the project.

The order was issued amid complaints by local environmentalists and stakeholders that the project is being developed in the vicinity of Mt. Isarog Natural Park.

Park.
Former DENR Bicol regional director Gilbert Gonzales issued an ECC for the project on Nov. 11, 2009.
The Ateneo de Naga University, non-government organizations and the Institute for Environmental Conservation and Research (INECAR) said the development of the 17.770.50 square meter Rangas hydro power plant project is in violation of the National Integrated Project Area System or the NIPAS Act of 1992.

INECAR spokesperson Joanaviva Pelopenio said based on a Global Positioning System (GPS) plotting of the boundaries of the 10,112 hectares of the Isarog National Park, the site development of the mini-hydro power plant in Bgy. San Pedro (Aroro) Goa town in the portion of Mt. Isarog falls inside the natural park and not outside its boundary.

The INECAR said about 63 mature trees will be affected by the project.

Many stakeholders among the water district offices in Camarines Sur also opposed the project. They said they were not informed of the planned construction of a hydro power plant in Mt. Isarog, considering that

a hydro power plant in Mt. Isarog, considering that potable water sources in Naga City and the adjacent towns come from the mountain's watershed.
