## Collect rain water to help lessen demand

The Department of Environment and Natural Resources (DENR) has urged Metro Manila residents to take advantage of the rain

showers occurring in the afternoon or evening, by collecting and recycling water for non-essential uses, such as car washing, watering of plants, and toilet flushing.

"Angat Dam can still benefit from the rains falling outside its watershed if these are collected for nonessential uses such as for carwashing and flushing of toilets," DENR Secretary Roy Cimatu said.

DENR made the call amid insufficient rain over the 62,300hectare Angat Watershed Reservation in Bulacan.

Cimatu said that simple water conservation measures could help lessen the demand for Angat Dam's water in the millions of liters.

# DENR urges: Conserve water

## Even during rainy season

The rainy season does not assure ample water supply

The Department of Environment and Natural Resources (DENR) on Thursday urged Metro Manila residents to still conserve water even on the onset of the rainy season in the country.

In a statement, the DENR said metro residents should continue observing water conservation measures and recycle rain showers to help prevent further decline of the water level in Angat Dam.

"Angat Dam can still benefit from the rains falling outside its watershed if these are collected for non-essential uses such as for carwashing and flushing of toilets," said Envrioment Secretary Roy Cimatu.

This follows after insufficient rain over the 62,300-hectare Angat Watershed Reservation put it in danger of going into critical levels even as heavy rainfall have been observed in many parts of Metro Manila.

The Environment Secretary said simple water conservation measures could help lessen the demand for Angat Dam's water in the millions of liters as the dam supplies 96 percent of Metro Manila's tap water needs for its 12.8 million residents.

Water from the dam comes from the watershed's river basin that straddles the towns of Doña Remedios Trinidad, Norzagaray and San Jose Del Monte in Bulacan.

"We can reduce water wastage by using only what is required. We can also collect and reuse rainwater," Cimatu said, noting that the insufficient rainfall over Angat watershed is compounded by the "monsoon breaks" which weather bureau Pagasa explained is a shift between weather systems that result in short breaks to no rainfall for several days or weeks.

Cimatu also called on local government units (LGU) in Metro Manila to prioritize the passing of an ordinance directing their constituents to observe water conservation practices.

"It is high time that the LGU pass ordinances geared at water conservation to prevent the water problem from worsening," Cimatu said, adding that these ordinances can have "immediate positive effect" to the water and food security being pushed at the national level by agencies like the DENR, the Department of Agriculture, the National Water Resources Board and the National Irrigation Authority.

Water in Angat Dam, which supplies 96 percent of Metro Manila's tap water needs for its 12.8 million residents, comes from the watershed's river basin that straddles the towns of Dona Remedios Trinidad, Norzagaray and San Jose Del Monte in Bulacan.

"We can reduce water wastage by using only what is required. We can also collect and reuse rainwater," Cimatu said.

Cimatu noted that the insufficient rainfall over Angat watershed is compounded by the "monsoon breaks" which PAGASA explained is a shift between weather systems that result in short breaks to no rainfall for several days or weeks.

As of Tuesday, the water level of Angat Dam has further declined to 161.76 meters, which is just 1.76 meters short of its 160-meter critical level for domestic water supply. **Joel dela Torre**



## Water ration looms as Anga rs critica

The National Water Resources Board (NWRB) on Thursday urged Metro Manilans to save water, warning that it might impose rationing if the stock in Angat Dam dropped below the critical level.

Angat Dam, in Bulacan province, supplies 90 percent of Metro Manila's water needs.

The Angat stock has been dipping since the peak of summer, causing a knock-on effect on the reserve at La Mesa Dam in Quezon City.

In March, the water elevation at La Mesa Dam breached the critical low level of 69 meters above sea level (masl), setting off a water crisis in the east zone that the private distributor Manila Water Co. Inc.

failed to anticipate.

#### Cloud-seeding

The government has been trying since early June to replenish the Angat stock through cloud-seeding, but the summer heat, which lingers despite the onset of the rainy season, has prevailed.

On Thursday morning, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (Pagasa) reported that the water elevation in the dam had dipped further to 160.50 masl, nearly breaching the critical level of 160 masl.

The dam's minimum operating level is 180 masl. The reserve was 161.20 masl on Monday and was going down at about 0.4 meter daily, Pagasa said.

To conserve the stock, the NWRB reduced the raw water allocation for Metro Manila, forcing the two private distributors to announce earlier this week rotating service interruptions.

But taps ran dry even before the schedules of service interruption could start, causing a public uproar that compelled the Metropolitan Waterworks and Sewerage System (MWSS) to warn the distributors on Thursday that it would fine them if they failed to follow their own timetables.

Maynilad Water Services Inc. on Thursday began implementing throughout its west zone concession rotational, daily service interruptions lasting seven to 14 hours.

Manila Water also began implementing a revised schedule for the east zone "for about eight to 12 hours during nighttime."

Manila Water's customers have been enduring A4

low pressure to no water since March, when the La Mesa Dam stock dipped to lower than the critical level.

It seems to be an unending problem that has become worse in recent days because of erratic

"The MWSS regulatory office has determined that the two concessionaires have failed to observe the water service interruption schedules that they announced," the agency's chief regulator Patrick Ty said in a statement on Thursday.

"While the two [companies] may not be blamed for the current water supply situation . . . the schedules are well within their control, and for which they may be held accountable," Ty added.

He said regulators would consider any period of actual service interruption occurring outside the schedule as "not having been the subject of proper notice to the customers.'

"Should such nonadherence continue, this may constitute a violation of the concession

#### Bayan Muna warning

The MWSS meted out a P534-million fine to Manila Water for its failure to provide 24-hour service to its customers for 15 days in March.

The fine comes in the form of a rebate to customers, which is reflected on their bills for June.

Militant party list group

Bayan Muna on Thursday warned Manila Water that it would file another complaint against the distributor for more rebates if it could not end the water problem in the east zone.

Mary Joy David, project development officer at the Bureau of Soil and Water Management (BSWM), on Thursday said the agency would extend cloud-seeding hours to help generate rainfall over Angat Dam.

The BSWM has been sending up two to three cloud-seeding

riights whenever experts spot clouds over the dam, David said.

Each flight runs an hour and carries 25 sacks of iodized salt, each weighing 25 kilograms, to be thrown into the clouds to induce a chemical reaction that causes rain.

David said the bureau had already conducted 50 hours of cloud-seeding operations since June 7.

Water elevation at Angat has not reached precarious levels since 2010, when a strong El Niño caused very dry conditions in the Philippines.

The consumer group Laban Konsyumer on Thursday called on the NWRB to lift the ban on deep well drilling in Metro Manila to ease the water problem in the metropolis.

In a statement, Victorio Dimagiba, the group's president, said the ban could be lifted until the stock in the dams had been replenished.

Since the water shortage in the east zone in March, the NWRB had allowed Manila Water to reactivate old wells for it to have additional sources of water. —WITH A REPORT FROM MELVIN GASCON INQ

The NWRB said that since Wednesday, allocation for Metro Manila's water concessionaires was already reduced from the original 46 cubic meters per second to 40 CMS.

NWRB executive director Sevillo David said that if there will be a further drop in Angat's water level to below 160 meters, they will be forced to implement a 36 CMS allocation to MWSS, which might take effect on Saturday.

The water in Angat Dam, which supplies 96 percent of Metro Manila's tap water needs for its 12.8 million residents, comes from the watershed's river basin that straddles the towns of Doña Remedios Trinidad, Norzagaray and San Jose del Monte in Bulacan.

The NWRB also said that apart from reduction of water allocation, several measures will be undertaken to manage the remaining water, including the operationalization of the Angat Dam Low Level Outlet (LLO), the bottom channel capable of releasing water below 160 meters.

"We have started to rehabilitate and subject the LLO to tests since March. It showed that water quality there is manageable," David

## Warning to water firms

The MWSS has warned the two concessionaires Maynilad Water Services Inc. and Manila Water Co. Inc. that they could be held liable for the schedule of water supply interruption especially now that allocation has been further reduced as Angat Dam nears the critical threshold.

The MWSS-Regulatory Office warned Maynilad and Manila Water to follow their published schedule of water interruptions or face possible penalties.

"Should non-adherence continue, this may constitute a violation of the concession agreement and the MWSS-RO shall recommend the imposition of appropriate penalties," MWSS chief regulator Patrick Ty said.

Both concessionaires are required to notify their customers of any planned service interruptions under their concession agreement.

NWRB continues to finetune the preparation of the LLO as a back-up water discharge before the Angat Dam water level reaches 160 meters and lessen the significant effect of limited water supply in the coming days.

With the cut in allocation, 75 percent of the customer base of west zone concessionaire Maynilad will be affected while more than 80 percent of east zone Manila Water will be hit.

NWRB is urging the public to conserve water to reduce the water demand from Angat to prevent the rapid decline of water level and contribute to its recovery. – With Louise Maureen Simeon



With no rains expected until this weekend, Angat Dam's level may reach the critical mark of 160 meters in just one or two days. Two days ago, the level was pegged at 161.78 meters

State weather bureau Philippine Atmospheric, Geophysical and Astronomical Services Administration (Pagasa) on Thursday warned that Angat Dam - which supplies water to Metro Manila and Central Luzon

areas - may hit critical level in one or two days.

According to Pagasa weather forecaster Benison Estareja, Angat Dam has dipped to 160.73-meter mark as of 6 a.m. Thursday.

With no rains expected until this weekend, Estareja said that the dam's level may reach the

critical mark of 160 meters in just one or two days. Two days ago, the level was pegged at 161.78 meters.

The National Water Resources Board (NWRB) last month already slashed water allocation for agriculture, saying this would not affect food supply because farmers were already in the middle of the planting season.

Regulators also said the allocation for Metro Manila's water supply may be reduced if the dam hits the 160-meter critical level. In fact, there are already scheduled water disruptions in

some parts of the capital region.

The dam's declining water level, lack of rains due to El Niño and high demand were blamed for a water supply shortage that brought misery to more than a million households in Metro Manila last March.

Angat Dam supplies 90 percent of Metro Manila's water requirement.

Pagasa on Friday declared the start of the rainy season, but weak El Niño conditions which were felt in the tropical Pacific since the last quarter of 2018 is "likely to continue" until August.

Relatedly, the Ecology Ministry of the Archdiocese of Manila has proposed the rehabilitation of Wawa Dam in Rizal to address the water supply shortage.

"We are saying that, why not restore and rehabilitate Wawa Dam? It is the original water source of Metro Manila since the time of the Americans," said Lou Arsenio of the Ecology Ministry of the Archdiocese of Manila.

An abandoned dam built during the American era in the early 1900s, Wawa Dam has long been seen as a better option for the water supply in the metropolis, as it does not require an expensive treatment technology like reverse osmosis. Specifically, the Wawa Dam catchment area traverses the municipality of Rodriguez and Antipolo, both in Rizal province.

According to Arsenio, it can be reconstructed instead of building a new dam. He also reminded the public about responsible use of water.

"The water demand is just too big and residents do not really save. Second is wastage of water and excessive use of the washing machine, "Arsenio said.

# Water concessionaires face possible penalties

THE Metropolitan Waterworks and Sewerage System-Regulatory Office (MWSS-RO) warned Manila Water Co. and Maynilad Water Services Inc. of possible penalties if they fail to properly notify their customers of the water service interruptions.

"The MWSS-RO has determined that the two concessionaires have failed to observe the water service interruption schedules that they announced. Under the concession agreement, Manila Water and Maynilad are required to notify their customers of any planned water service interruptions," said Patrick Ty, MWSS chief regulator.

Ty did not specify the penalties. He said the concessionaires may not be blamed for the current water shortage since the National Water Resources Board (NWRB) reduced their allocation from the Angat Dam, their water service interruption schedules are "within

their control, and for which they may be held accountable."

Ty said MWSS will consider any period of actual water service interruption that takes place outside the announced schedules as not having been the subject of proper notice to the customers.

"Should such non-adherence continue, this may constitute as a violation of the concession agreement ant the MWSS-RO shall recommend the imposition of appropriate penalties," he warned.

According to the National Power Corp., as of 6 a.m. yesterday (June 20), Angat Dam's elevation is already at 160.71 meters which is approaching near the 160 meters critical level.

NWRB earlier said that the 160 meter level is projected to be breached on June 22 and will trigger another allocation adjustments to the concessionaires as there will be a need for the auxiliary unit to be shut down and will further affect the available supply.

# Maynilad, Manila Water warned

#### BY JORDEENE B. LAGARE

HE Metropolitan Waterworks and Sewerage System-Regulatory Office (MWSS-RO) warned water concessionaires Manila Water Co. Inc. and Maynilad Water Services Inc. that they may be sanctioned for their failure to follow the scheduled water service interruptions.

"The MWSS-RO has determined that the two concessionaires have failed to observe the water service interruption schedules that they announced. Under the Concession Agreement, Manila Water and Maynilad are required to notify their customers of any planned water service interruptions," MWSS chief regulator Patrick Lester Ty said. Ty said the agency shall recommend the imposition of "appropriate penalties."

The MWSS-RO will take into consideration any period of actual water service interruption that occurred outside the schedule announced by Manila Water and Maynilad since customers were not properly informed.

"While the two concessionaires may not be blamed for the current water supply situation since the National Water Resources Board (NWRB) reduced their allocation from Angat Dam, the water service interruption sched-

ules are well within their control, and for which they may be held accountable," Ty said.

Manila Water, which has yet to fully restore its services following supply lack in March, was slapped with a P1.13-billion fine in April for its failure to meet its service obligation of round-the-clock supply to all its customers.

The NWRB reduced water allocation from Angat Dam, which supplies the water needs of Metro Manila, from 46 cubic meters per second (cms) to 40 cms.

Ty said the agency

issued a "stern warning" to the two water firms in relation to the schedule of water service interruptions posted by both companies.

The two firms have started implementing service disruptions in Metro Manila as well as parts of Rizal and Cavite provinces after regulators reduced water supply from Angat Dam.

Service disruptions in the metropolis and nearby provinces lasting for 7 to 14 hours were implemented during nighttime or off-peak hours.

Both

Maynilad and Manila Water had said their customers would continue to experience little to no water supply until their allocation from Angat Dam is increased.

As of Thursday, Angat's water level was 160.73 meters, a mere 0.57-meter away from its critical level of 160 meters.

Philippine Atmospheric, Geophysical and Astronomical Services Administration hydrologist Richard Orendain expects the dam

to reach its critical level mark in two



## Led by Padilla, NV hits miner's license renewal

BAYOMBONG—Hundreds of citizens of Nueva Vizcaya province gathered at the Provincial Capitol on Thursday to protest and call on President Rodrigo Duterte to deny an Australian-Canadian large-scale miner's petition for a renewed license to operate.

The protesters were reacting to news that the application for renewal of the Financial or Technical Assistance Agreement license of the OceanaGold mining firm has already been endorsed by the Department of Environment and Natural Resources to the Office of the President.

Led by Nueva Vizcaya Governor Carlos Padilla, the anti-mining protesters presented Environment Secretary Roy Cimatu with a list of "lapses, human rights abuses, non-compliances to memoranda of agreements, and others like violations," the group said in a statement.

Padilla met with Cimatu Wednesday night with Bishop Elmer Mangalinao of the Archdiocese of Bayombong, Liga ng mga Barangay Federation Chair Vic Gines and other anti-mining advocates.

OceanaGold's supposed violations, the group said, are in open-pit mining, Provincial Comprehensive Land Use Plan and Provincial Physical Framework and Development Plan that prioritizes Nueva Vizcaya as the watershed haven that supports the irrigation for neighboring provinces like Quirino, Isabela, Cagayan and Nueva Ecija.

The governor even lamented that the Mines and Geosciences Bureau in Region 2 were the ones giving support to OceanaGold, who could not be contacted for a statement at press time.

# Asean may tackle sea disputes; garbage dumping not on agenda

BANGKOK – Bitter disputes over competing claims in the South China Sea are likely to surface at the two-day Association of Southeast Asian Nations (ASEAN)

Some officials in Manila initially blamed Chinese sailors for deliberately ramming the boat and leaving Filipino fishermen stranded at sea. But President Duterte

meeting starting Saturday in this Thai capital after the sinking of a Filipino fishing boat in the resource-rich waterway. this week downplayed the incident, saying it was "just a collision."

the urgent need for toughened-up terms in a Code of Conduct for clashes between fishermen at sea, said Manila-based security analyst Richard Heydarian.

"If the Chinese don't rein in these fishermen... this is just going to get worse," he said.

### Dumpsite of the world

Campaigners are also urging ASEAN leaders to tackle the mounting problem of plastic and electronic waste – much of it imported from Western nations and accumulating in Southeast Asia.

Greenpeace this week said the region has become "the world's new dumpsite."

Protesters in Bangkok yesterday dumped plastic waste in front of a government building and called on Southeast Asian leaders to ban imports of trash from developed countries.

A group of about 50 Thai activists, some holding placards reading "No Space for Waste," joined Greenpeace campaigners to call for an end to all trash imports to Southeast Asia.

"The communities are

here today to reclaim... the right to live in a sustainable environment in Thailand," said Tara Buakamsri of Greenpeace Thailand.

They called for ASEAN countries to ban the export of waste "from anywhere in the world into the region," Tara said.

The trash pile-up in Southeast Asia accelerated after China stopped accepting was te in 2018, and Greenpeace says plastic refuse imports have increased by a staggering 171 percent since 2016.

The imported waste is supposed to be recycled, but sometimes arrives mixed with unrecyclable items or is improperly handled and ends up being burnt or leaking into waterways and the sea.

The issue has been in the headlines recently after the Philippines sent a huge shipment of garbage back to Canada, sparking a diplomatic row.

And last week, Indonesia returned five containers of rubbish to the US, saying it refused to be a "dumping ground."

Thailand currently imports waste from scores of countries, much of it ending up in landfills and waste disposal facilities that have prompted pollution complaints from residents.

# Land-area data gaps

# impact SC tax ruling

HE National Land Use Committee (NLUC) aims to address discrepancies in the computation of land areas being contested by the majority of local government units (LGUs) nationwide before 2022, according to the National Economic and Development Authority (Neda).

Neda Regional Development Office (RDO) Undersecretary Adoracion M. Navarro told the BUSINESS-MIRROR that 71 percent of cities and municipalities are contesting their land areas, even after a nation-wide cadastral survey conducted by

the Department of Environment and Natural Resources (DENR) Land Management Bureau (LMB).

Navarro said there is a need to resolve these concerns before 2022, given the Supreme Court's final decision granting the petition of Batangas Gov. Hermilando I. Mandanas to automatically release the internal revenue allotment (IRA) of LGUs

"The LMB's land measurements are the result of the 2011-2015 nationwide cadastral survey program of the government. Since the LMB is the foremost expert in these matters, the national government must find a way of making the expert's result acceptable to the LGUs. And it must do soon, especially because there will be a bigger pie for LGUs come 2022, given the Supreme Court's final decision on the Mandanas petition," Navarro said.

Navarro explained that a land area impacts LGUs significantly given that it helps determine the level of their IRA and revenue col-

lections, as well as shapes its politics, particularly during elections.

After the LMB's cadastral survey, however, Navarro said 1,163 of the 1,634 cities and municipalities nationwide are contesting the survey results. She said these LGUs are contesting the results at the LMB.

"If an LGU's land measurement is different from the old one and DBM adopts the new measurement, the LGU's IRA share will also be affected. Since the LGUs also have land-based revenue collections, a change in the measurements of their lands, once officially accepted, will also affect their revenue collections. The change will also affect the setting of political boundaries for various purposes, like election,"

Navarro explained.

In April, the Supreme Court maintained its decision which declared that the IRA share of all LGUs must be based on the collections of all national taxes, and not only from national internal revenue taxes collected by the government.

In its July 3, 2018, decision, the Court increased the IRA of LGUs to include the tax collection of other agencies aside from the BIR as basis for the computation.

It included tariff and duties collected by the Bureau of Customs, 50 percent of value-added tax, 30 percent of national taxes collected in the Autonomous Region in Muslim Mindanao, 60 percent of national taxes collected from the exploitation and development of national

wealth, 85 percent of excise tax from tobacco products, and a portion of franchise tax under Republic Acts 6631 and 6632 (Horse Racing Laws), among others.

The Court's decision stemmed from the petition filed in January 2012 by former Batangas Second District Rep. and now Provincial Gov. Hermilando Mandanas.

The SC voted 10-3 to partially grant the petition of Mandanas, who had questioned the process of allocating IRA funds for the LGUs.

Section 284 of Republic Act 7160, which created LGUs, stated that provincial, city and municipal governments should receive 40 percent of total national internal revenue taxes collected by the national government.

## By 2050, what if we can't see the forests or the trees?

OST of us are familiar with the saying that sometimes we "can't see the forest for the trees." But what if I told you, at our present rate of exploitation of our forests and depletion of our natural resources in Asia and the Pacific, that we run the risk of not seeing the forests or the trees by the middle of this century?

As a region, Asia and the Pacific has more people than any other part of the world and many areas within have very high population densities. As a result, nearly two-thirds of the forests in this region have been degraded to various degrees. Only 19 percent of primary forests remain (where human intervention has been minimal), compared with the global average of 32 percent. So what will the future of our forests look like? Will we continue down this road or will we work together to improve things?

To get a better understanding of the way forward, the Food and Agriculture Organization of the United Nations (FAO) has just published a wide ranging and comprehensive review of the forest sector in the Asia-Pacific region. It examines trends from the last 25 years, the current state of forests and forestry, and provides an outlook for their future to 2030 and beyond

This report is unique because it

looks well beyond the horizon to what our forests could look like by midcentury. I say "could look like" because the mid-century predictions depend largely on the path we take through our forests in the coming years and

The report, Asia-Pacific Forest Sector Outlook Study III, outlines some immense challenges ahead.

First, the population of Asia and the Pacific is expected to add another 500 million people by 2030, rising to 650 million more by 2050, when about two-thirds of the region's populations are predicted to be living in urban areas. Second, the middle class is expanding in most countries. On one hand, this increases demand for forest products and on the other, adds pressure to convert forest areas into agricultural land for a variety of uses such as animal production. These demands will add further pressure on natural resources such as soil and

Already, the report finds, deforestation has, through the years, left the region with huge areas of secondary forests. While replanting is, of course, to be encouraged, the loss of biodiversity from disappearing primary forests is a major concern.

The report warns that business as usual will lead us down a path that no one really wants to travel, a dead end future where natural resources have been squandered and exhausted. It suggests a more aggressive move toward an integrated landscape management plan that systematically deals with improvements in all natural resource areas—landscapes, forests, soils, water-and benefits communities.

Innovations-making use of powerful new technologies-are needed for improved governance and management to cope with future demands on forests and landscapes, including those in urban and peri-urban areas.

Clearly there is a role for all of us to play. There is an urgent need for societies to reduce consumption, increasingly reuse instead of discarding, and sustainably produce biomaterials in forests. In short, we need to find innovative ways to balance competing demands that will benefit us all.

There are, however, reasons to be optimistic and they are worth mentioning. The rate of deforestation has been slowing in recent years. And, overall, big shifts in the way we interact with forests and landscapes are happening due to demographic changes, economic progress, technological advances, environmental awareness and improvements in governance. The traditional use of wood as a source of domestic energy is declining rapidly, due largely to increasing incomes, urbanization and the substitution of wood with electricity and LPG. The use of printing paper has declined as our society has shifted to online media and paperless workplaces.

To make sure our region maintains some of these good approaches and deals with some of the earlier mentioned challenges will take political will and cross-country cooperation of all stakeholders.

At the end of the day, if carefully managed, forests offer solutions to food insecurity, climate change, waterscarcity and energy demands—but we will only take advantage of these if we take corrective action—and do so quickly. To ensure a positive and resilient future for everyone, we need to avoid going beyond the tree line.

## Hot logs, lumber seized in Surigao

BUTUAN CITY – A police patrol intercepted a van loaded with illegally cut logs and lumber products in Sitio Dalit, Barangay San Isidro, Gigaquit, Surigao del Norte, early this week, Lt. Col. Christian L. Rafols II, chief of Regional Public Information Office of Police Regional Office 13 told Manila Bulletin.

"No cutting permit and no transport documents were presented by the driver and helpers during initial investigation," police reported.

The identities of the driver and helpers were temporarily withheld as the financier or owner of the seized products was still to be determined as of Thursday

The van yielded 33 round logs and 9 freshly sawn lauan.

The van and its cargo were taken to the Community Environment and Natural Resources Office (CENRO) Depository compound in Tubod, Surigao del Norte, for final scaling and safekeeping.

CENRO officer Joseph Leo Oconer said the Tubod CENRO office and police is preparing charges against the suspects, the owner of the van and the owner of the seized forest products. (Mike U. Crismundo)

# Asean ban on trash im

ANGKOK—Protestors in Bangkok on Thursday dumped plastic waste in front of a government building and called on Southeast Asian leaders to ban imports of trash from developed countries.

The protest comes ahead of a weekend meeting of the 10-member Association of Southeast Asian Nations, with many countries struggling to deal with the flood of plastic waste unleashed by China's decision last year to stop importing recyclables from abroad.

Countries in ASEAN now receive more than a quarter of global plastic waste, most of which comes from developed economies like Canada, the US, Australia, and Japan.

A group of about 50 Thai activists,

some holding placards reading "No Space for Waste", joined Greenpeace campaigners to call for an end to all trash imports to Southeast Asia.

"The communities are here today to reclaim... the right to live in a sustainable environment in Thailand," said Tara Buakamsri of Greenpeace Thailand.

They called for ASEAN countries to ban the export of waste "from anywhere in the world into the region," Tara said.

The trash pile-up in Southeast Asia accelerated after China stopped accepting waste in 2018, and Greenpeace says plastic refuse imports have increased by a staggering 171 percent since 2016.

The imported waste is supposed to be recycled, but sometimes arrives mixed with unrecyclable items or is improperly handled and ends up being burnt or leaking into waterways and the sea.

The issue has been in the headlines recently after the Philippines sent a huge shipment of garbage back to Canada, sparking a diplomatic row.

And last week, Indonesia returned five containers of rubbish to the US, saying it refused to be a "dumping ground."

Thailand currently imports waste from scores of countries, much of it ending up in landfills and waste disposal facilities that have prompted pollution complaints from residents.

"There is air, dust, and water pollution... it burdens the Thai people," said Jorn Naowaopas, an activist from Chachoengsao province where several dumpsites are located.

The contaminated groundwater run-off and toxic fumes caused by disposing of plastic and electronic waste can cause serious environmental and health problems if not properly treated.

The ASEAN summit, which kicks off Saturday with a foreign ministers meeting, has not put the waste issue on its agenda.

But discussions will have as a "priority" the issue of marine waste because it affects "the food chain of people worldwide," Thai government spokesman Werachon Sukondhapatipak said Wednesday. AFP

# Air pollution ranked as biggest environmental threat to human health

**UNITED NATIONS:** In a world that is becoming more and more industrial by the day, air pollution appears to be on the rise.

While there have been efforts in major cities to combat the grave effects that pollution can have on the overall health of its citizens, there is still more progress to be made.

Karen Beck Pooley, a Professor of Practice of Political Science and the Director of Lehigh University's Environmental Policy Design program, told IPS: "One thing that we've always known but we haven't paid as much attention to until fairly recently is the degree to which people's immediate environments affect their health."

The importance of recognizing air pollution as a prevalent problem was emphasized by the theme of the recent 2019 World Environment Day, with official celebrations held in this year's host country, China.

Additionally, reports such as the one released recently in Sarajevo, and titled "Air Pollution and Human Health: The Case of the Western Balkans," highlighted the adverse effects on the public.

Talking on the implications of air pollution, Catriona Brady, head of the World Green Building Council's Better Places for People campaign told IPS that, "air pollution is considered to be the biggest environmental threat to human health today."

"Research shows that over 90 percent of people across the world are exposed to unsafe levels of air pollution, which includes both the population in big cities and small communities. The effect this pollution has on citizen health is quite horrifying — studies suggest that almost every organ of the human body can be affected by toxic airborne particles, and this is resulting in an approximate 7 million premature deaths each year."

Pooley notes that the actual planning of cities can have an impact on the amount of pollution produced, saying that, "The way we build our cities and the way people organize their lives in them, affect how much we need car travel or truck traffic. Or environmentally dirty things that we need like trash facilities and where these things are located and who's living in the midst of the effects of those things."

While there are positive plans, such as Canadian Prime Minister Justin Trudeau's decision to phase out coal usage in his country by 2030 or Kenyan President Uhuru Kenyatta's plan to ban single-use plastics from being used in the country's national parks, there are also efforts being made on both smaller and larger scales worldwide.

Pooley observes that, "At the moment,

most of the environmental conservation work and attempts to reduce greenhouse gas emissions and things of that nature are coming from cities."

Brady says that her organization, "has embarked on a global 'Air Quality in Built Environment' campaign, in partnership with the Climate and Clean Air Coalition.

"With this work we've been raising awareness about the role of buildings and cities in generating emissions and air pollution, both inside and outside of buildings, and highlighting strategies that can be valuable to mitigate these. Step one is monitoring — as we can't reduce what we can't measure."

She also said: "We're advocating for the roll out of air quality monitors to provide detailed data on emissions across the world. With this data we're equipped with the necessary information to lobby our policy makers to make changes needed to clean up our energy grid, buildings, and air quality."

Pooley states that citizens can make small changes that will be helpful as well. "Cutting down on car travel can be a big help because so much pollution comes from cars. So, the more places that are walkable and bikeable and the more trips that are made by something other than cars, the less pollution we'll have."

Day to day actions can be quite helpful, but having policies put in place may also help deter the harmful effects that poor air quality is having on the lives of those who inhabit such areas.

Brady suggests something similar, while also maintaining that citizen action is important. Policy initiatives — such as the recent London Ultra Low Emission Zone — can help catalyze action toward clean air.

Policy enforcement around energy generation, building energy efficiency, construction practices, transport, waste and many other factors are vital to preserve citizen health.

"But the role of the citizen is also important; reducing the emissions from our lifestyle in terms of energy consumption and choices, diet, and transport methods are all achievable for the individual," said Brady.

"And if you're worried about being exposed to pollution by cycling or walking to work, then it's worth knowing that you're generally exposed to far higher levels of pollutants in a car in traffic or in an underground system!"

With world leaders proposing plans to help deter ruinous environmental effects and with cities implementing new policies to help out, it is clear that progress is being made in helping to create cleaner environments to live in.

THE Asian Development Bank's (ADB) is holding its 14th Asia Clean Energy Forum (ACEF) this week from 17-21 June 2019. The NGO Forum on ADB along with its member partners demands the ADB to meaningfully act on the urgency of climate crisis in the Asia - Pacific. In 2018, multilateral development banks (MDBs) including the ADB created a joint framework for aligning their activities with the goals of the Paris Agreement.

In ADB's Strategy 2030 it has increased its committed operations supporting climate change mitigation and adaptation to 75% in 11 years time and set to prioritize investments for a low-carbon economy. "However despite this rhetoric, ADB's deafening silence on retiring coal-fired power plants it had earlier funded in the region and banning financing for fossil fuels speaks in stark contrast with this commitment," Annabel Perreras, Advocacy Coordinator, NGO Forum on ADB.

CSOs demand that ADB, as a standard bearer for other MDBs, should adopt stringent measures in accordance with the 1.5-degree pathway. According to Rayyan Hassan, Executive Director of NGO Forum on ADB, "In order for the Bank to demonstrate its commitment in unambiguous terms, it should have a time-

bound phase-out plan for natural gas and intensify investments on renewable energy projects that are neither harmful to the environment nor to the affected communities."

According to Gerry Arances, Executive Director of Center for Energy, Ecology, and Development (CEED), "It is high time for ADB to make use of decentralized renewable energy microgrids like in the case of the Philippines. These have been proven to be an effective alternative in providing clean, affordable and accessible electricity particularly among unelectrified and remote households, small island grids and impoverished communities and even in metropolis like Metro Manila where electricity prices are rising"

Lastly, CSOs demand that the ADB should start pursuing distributed renewable energy systems because it maximizes energy access and advances energy democracy. It is designed on the principle of doing no harm to the environment, supports local economies and contributes to the health and well-being of all people. By investing in distributed renewable energy systems, essentially this also contributes to fulfilling ADB's commitment to improving governance and meet the Bank's stated objective of ensuring energy access for all.

# Tree-planting sa lloilo ngayong Sabado

INAASAHANG halos 1,000 volunteers ang makikiisa sa gaganaping treeplanting activity ng probinsiyal na pamahalaan ng Iloilo ngayong Sabado, Hunyo 22.

Sa pagbabahagi ni Lawyer Arturo Cangrejo, officer-in-charge ng Provincial Environment and Natural Resources (PENRO), sinabi nitong ang idaraos na treeplanting activity sa komunidad ng Pangilihan, Janiuay ay bahagi ng pagdiriwang ng Philippine Arbor Day tuwing ika-25 ng Hunyo.

"We propose to plant 7,500 seedlings, including forest trees and fruit-bearing trees, such as cacao, duhat (Java plum), and jackfruit," pahayag ni Cangrejo sa isang panayam nitong Martes.

Nanawagan naman si Cangrejo sa lahat ng mga katuwang na sektor, ahensiya at mga mamamayan ng Iloilo na makilahok din sa aktibidad na isasagawa.

Pinaalalahanan din niya ang mga makikiisa na magdala ng tubig ngunit inirekomenda niya na huwag gumamit ng mga single-use water plastic bottles.

"We advise them to bring their own water bottle. The PENRO will provide water to refill their containers," aniya.

Dagdag pa dito, hinikayat din niya ang mga lalahok sa programa na magsuot ng tamang kasuotan para sa aktibidad.

Magtatagpo, aniya, ang mga kalahok sa Ceres Motorpool, Dungon B village sa lungsod na ito ng distrito ng Jaro.

Taunang ipinagdiriwang ang Philippine Arbor Day upang maisulong ang mas malusog na ecosystem.

Isinasaad sa Proclamation No. 396 ang "active participation of all government agencies, including government-owned and -controlled corporations, private sector, schools, civil society groups, and the citizenry in the tree-planting activity."



### Preparing for another Ondoy

Ten years ago,
Tropical Storm
Ondoy dumped a
month's average volume of
rainfall in just six hours in many
areas of Luzon. During that
brief period, people, cars and
shanties were carried away by
rampaging floodwaters in Metro
Manila. Residents scrambled to
their rooftops as floods rose at
incredible speed, inundating

homes, shutting down roads and isolating many areas.

A week later, families were still mourning the hundreds who died and the floods had not yet subsided in many communities when Typhoon Pepeng ravaged the same areas, aggravating the suffering of those affected by Ondoy. After several weeks, the floods still had not completely subsided in certain communities such as those around Laguna de Bay, where residents also had to contend with an outbreak of leptospirosis.

Weather experts EDITORIAL attributed the heavy rainfall to an El Niño phenomenon in that year. Meteorologists explain that the unusually warm ocean temperature in this part of the planet during an El Niño triggers strong evaporation and condensation, producing heavy rainfall during the wet season. The weather experts have alerted the public to prepare for the possibility of Ondoy-like storms this year following the drought that has dried up farmlands and led to water rationing even in Metro Manila.

The death and destruction from Ondoy and Pepeng led to the enactment of Republic Act 10121, the Philippine Disaster Risk Reduction and Management Act of 2010. RA 10121 provides a framework for dealing with natural calamities. The law must be revisited to ensure that all sectors are sufficiently prepared for another Ondoy.

# DELAY ON ROAD REPAIR HAMPERS GARBAGE COLLECTION

### **IN BULACAN TOWNS**

CITY OF SAN JOSE DEL MONTE—Tons of garbage remain uncollected in seven towns and a city in Bulacan province as repairs on the damaged road leading to a private sanitary landfill here have been delayed.

Gov. Wilhelmino Sy-Alvarado called for an emergency meeting on Thursday to seek solutions to a looming garbage crisis.

Dump trucks of the Wacuman sanitary landfill at Barangay San Mateo in Norzagaray town had stopped hauling garbage on May 24 after a portion of Igay Road here collapsed due to landslides caused by incessant rains.

Gerry Cenal, Wacuman architect and administrator, said the road collapsed due to its substan-

dard materials. The road is 3 kilometers from the Wacuman dump.

Elizabeth Apresto, head of the Bulacan provincial environment and natural resources office, said the road had not been repaired due to legal issues.

Some of the affected towns

have identified landfill areas in the provinces of Pampanga, Tarlac and Rizal, and in Navotas City in Metro Manila as alternative dumps.

Emelita Lingat, head of the Department of Environment and Natural Resources in Bulacan, said her office had been monitoring if local governments were already sending their garbage to sanitary landfills outside the province.

But Apresto said local governments in the towns of Bulakan, Baliwag, Paombong, Hagonoy,

Doña Remedios Trinidad, San Miguel and Balagtas, and the City of Malolos had yet to remove their garbage that had piled up on the streets and in residential areas.

"Some of the affected local governments find it expensive to take their garbage outside the

province and are just waiting for Wacuman landfill to operate again," Apresto told the Inquirer.

#### Closure

On April 22, Mayor Alfredo Germar of Norzagaray ordered the closure of Wacuman dump for operating without a business permit.

The landfill operator had a dispute with the Bangko Sentral ng Pilipinas over property ownership but the firm had continued operating despite this.

Lormelyn Claudio, Environmental Management Bureau chief in Central Luzon, earlier directed the affected local governments to resolve the garbage problem within a week. —CARMELA REYES-ESTROPE INQ



# Negros governor open to coal plants

ACOLOD CITY: Governor-elect Eugenio Jose Lacson said he would not refile the proposed ordinance to declare Negros Occidental as "coal free," which will virtually open the province to investors wanting to put up a coal-fired power plants.

Lacson said right now, Executive Order (EO) 19-08, as issued by outgoing governor Alfredo Marañon Jr. on March 7, does not carry much weight.

The EO declares that only clean and renewable sources of energy will be allowed in the province.

It reinforces the Renewable Energy (RE) Act of 2008, which encourages the development and utilization of RE sources as tools to effectively prevent or reduce harmful emissions thereby balance the goals of economic growth and development while protecting health and environment.

"More and more countries have been decommissioning its coal-fired power plants due to the damage it causes to the environment and in fact have been shifting to RE projects," it said, adding that with proper technology transfer, the province has the landscape, capac-

ity, and resources for further development and investment in RE projects.

The EO also tasked all department heads in the provincial government to pursue a policy on renewable energy.

It also directed the establishment of the Provincial Renewable Energy Council, a policy-making body in formulating measures encouraging renewable energy programs for a greener and energy-sufficient province. The council will be chaired by the governor.

The order also recommended to the Sangguniang Panlala-wigan (Provincial Council) the passage of Renewable Energy Ordinance, further stating opposition to the setting up of a coal-fired power plant in the province

However, this has not been

acted upon by the Sanggunian Panlalawigan.

Meanwhile, the committees on energy and environment, which were tasked to conduct hearings, have not submitted any report yet.

Board member Romel Debulgado, chairman of the Committee on Environment on Wednesday, said they already visited the coal plant in Iloilo City.

According to Debulgado, there was no significant impact on the environment despite being located in the city proper.

He said it also spurred the economy in the surrounding communities.

In 2018, the SMC Global Power Corp. expressed its intention to develop a 300-megawatt circulating-fluidized-bed coalfired power plant in San Carlos City, Negros Occidental.

ernment needs to adopt a new method for estimating disaster damage that goes beyond asset losses, because the current approach tends to highlight the value of projects in or near the National Capital Region (NCR).

In its "Lifelines: The Resilient Infrastructure Opportunity" report, the World Bank said: "the most impor-

tant interventions will take



in the Manila area if asset losses are the main measure of disaster impacts."

"Assessments of national risk and identification of critical infrastructure need to account for multiple policy objectives and therefore, use a set of metrics that goes beyond asset losses," it added.

The World Bank noted that the Philippines was able to save more than \$1 billion because of natural systems that protect the coastlines against flood and storm surges. It said that nature-based solutions for flood protection reduce the need for hard infrastructure such as dikes.

"In the Philippines, mangroves, reefs and other natural system prevent more saster losses," the bank said.

Other countries that benefit from the protection provided by reefs are Cuba, Indonesia, Malaysia and Mexico, the World Bank said, noting that these countries save an estimated \$400 million each from flood damage annually.

The World Bank also noted the importance of service

having gencv plans in

case of power interruptions.

"In the Philippines, after a typhoon, water tankers (have been) contracted to ensure service continuity despite infrastructure damage."

The World Bank said it is necessary for resilience measures to be fairly distributed across populations and backed by metrics based on socioeconomic impacts on the affected population.

In a separate statement. World Bank Group President David Malpass said, "Resilient infrastructure is not about roads or power plants alone. It is about the people, the households and the communities for whom this quality infrastructure is a lifeline to better education and better livelihoods."

### **Unending controversies**

Since the start of his term in 2016, controversies and confusions continue to hound Duterte (PRRD) and his administration. And it is quite clear that no one else can be blamed except PRRD himself and his officials. Their unclear and sometimes contradicting statements have really



brought about so many controversies and have caused a lot of doubts and disorientations on so many people.

The most recent dissensions and disputes were about this government's refusal to allow the United Nations to investigate its various human rights violations. They have not yet completely died down but another controversy has already arisen. This is about the ramming and capsizing of a Philippine fishing boat with 22 Filipino fishermen on board by a Chinese vessel along the Recto Bank in the West Philippine Sea. The incident becomes even more striking and deplorable because the Chinese did not rescue the Filipino fishermen who were left adrift at sea for hours thus endangering their lives.

This maritime incident which occurred last June 9 should have elicited an immediate reaction from this government because the lives of 22 Filipinos were endangered and a Philippine fishing boat was damaged and sunk. Indeed the Captain of the Filipino fishing boat upon his rescue together with the rest of the fishermen by a Vietnamese vessel narrated that their boat was hit by the Chinese vessel causing it to capsize but its crew left them

Intriguingly, this government especially PRRD kept quiet for quite a time although his Defense Secretary Lorenzana has initially deplored such maritime disaster particularly his denunciation of the vessel's captain for not ordering the rescue of the Filipino fishermen. PRRD's silence once more drew lots of adverse comments, conclusion and speculations by most Filipinos. The more obnoxious among them is the observation that PRRD is really pro China as many have already surmised before. In fact he was even accused of treason for such long silence on the incident. His beleaguered Spokesman Salvador Panelo once more tried to explain PRRD's silence by claiming the President was just being cautious and want to get all the facts first.

I he most deplorable and unfortunate aspect of this episode is PRRD's assessment of the incident after being silent for more than a week. He downplayed the ramming of the Filipino fishing boat and declared that it was just "a little maritime accident." Such assessment again drew the ire of so many of our countrymen because PRRD seemed to confirm the belief of a great number of Filipinos that he is afraid of China and that he favors China and the Chinese over his own country and people. This is the consensus among a great number of Filipinos because even if the hitting of the fishing boat is just a minor event, the fact remains that 22 lives of Filipinos were endangered because the crew of the Chinese vessel did not rescue them and just left them adrift at sea. Such inhuman act cannot be definitely considered as a minor incident because the lives of our countrymen were exposed to great danger. PRRD's own Foreign Affairs Secretary Teodoro Locsin Jr. said in his speech at the UN Convention on the Law of the Sea (UNCLOS), said that "abandoning people in distress is a felony." Thus the government should have at least filed a diplomatic protest against China.

As it is now emerging, and based on the conclusions of most Filipinos, the long silence of PRRD and his officials on this maritime incident has a reason. They were indeed preparing sufficient proof to support their soft assessment. Thus the very captain of the fishing vessel has changed his tune and said that he did not actually see the whole incident as he was asleep when it happened. He even confirmed that the collision of the two boats was really an accident. His turn around came after Agriculture Secretary Emmanuel Pinol talked to him. So people are now concluding that the ship captain of the fishing boat was "convinced" to recant his previous declaration in order to support PRRD's assessment belittling the maritime collision. Another official who appears to have softened his stance and change his assessment of the maritime collision is Secretary of National Defense Delfin Lorenzana. While PRRD kept his silence on the matter, he already angrily denounced the incident and assailed the captain of the Chinese vessel for not rescuing the Filipino fishermen. Now he is defending PRRD's initial silence allegedly because he did not have enough information yet about the incident. Furthermore he now agrees with PRRD that the fishing boat incident really appears to be just a minor accident based on the information gathered. Then of course Presidential Spokesman Panelo also joined the chorus and disputed the notions that PRRD does not want to offend China when he broke his silence and came out with a statement that the sinking of the Filipino boat is a "little maritime accident."

This on-going notion about PRRD's being Pro-China or that he is "scared" of China will not be completely dissipated because PRRD's policies and actions really appear to favor China. When he assumed office, he already announced a major change in foreign policy by shifting his preference for China than the US. Such shift may really be for our best interest. The problem however is that people cannot erase the growing impression that our country is now under the control of China much like the previous relations we had with the US where we could not completely cut-off our dependence on said country after regaining our independence in 1946. So it will be better for this administration to refrain from appearing to be

too dependent on China also.

### Duterte off to Bangkok for Asean summit

President Duterte will leave for Bangkok today to participate in the 34th Association of Southeast Asian Nations (ASEAN) summit hosted this year by Thailand. He and his delegation will leave this afternoon from his home province Davao, Malacañang said.

He is expected to attend the ASEAN Leaders' Interface with representatives of ASEAN Inter-parliamentary assembly (AIPA) tomorrow, which follows an earlier meeting with heads of Thailand's top business groups.

The ASEAN Leaders' Interface will also be done with the ASEAN Business Advisory Council and representatives of the ASEAN Youth.

Barring any hitches, Duterte will be attending the 34th ASEAN plenary to be followed by the gala dinner, also on Saturday.

The President's schedule will be packed on Sunday with the ASEAN Leaders' retreat and the 13th Brunei-Indonesia-Malaysia-Philippines East ASEAN Growth Area (BIMP EAGA) Summit.

There are also efforts for a possible bilateral meeting between Duterte and Thailand's leader, the Department of Foreign Affairs said during the pre-departure briefing last Tuesday.

During the briefing for the media delegation, Foreign Affairs Assistant Secretary Junever Mahilum-

West said the issues over the incident at Reed Bank could be tackled during the ASEAN as he is not discounting the possibility that the Philippines may have an "opening" to discuss the matter during the exchange of views on regional developments.

The matter may also crop up during the discussions on regional and international developments as the South China Sea will be on the agenda and the leaders are going to exchange views on this issue, he added.

The Philippines is coordinator of the ASEAN-China dialogue partnership from 2018 to 2021.

During this coordinatorship, West said the Philippines is negotiating with ASEAN member-states and China on the Code of Conduct for the South China Sea, on the South China Sea.

"And in these negotiations, incidents like what happened to our fishermen will be among those on the agenda," he said.

"During the exchange of views on regional developments, there is an opening to raise these issues. Because incidents like what happened emphasize the importance of having a Code of Conduct so that we could avoid, we could prevent these incidents from happening in the future," West said.

### Accountability

The maritime incident near Recto Bank will soon be resolved – with the Philippines apologizing to China for causing trouble.

That was the joke yesterday following the amendment of the Filipino fishing boat captain's story of what happened on June 9. This was after Agriculture Secretary Manny

Piñol distributed cash assistance and 11 fishing boats to the 22 crewmembers of the *Gem-Vir* (*GemVer*) boat in their home province of Occidental Mindoro.

Piñol yesterday denied bribing or scaring the captain to change his narrative and apologize to President Duterte. The agriculture chief, who became the subject of nasty jokes, stressed that several of the other fishermen had not changed their stories about what happened.

With the Philippine government amenable to a joint investigation with China, however, a number of those who believed the fishermen's original narration of events have simply shifted to the national pastime of jumping to conclusions, giving up on any formal probe.

The Chinese government has a point: Beijing is enjoying the best of ties with Manila, thanks to the friendship offered by President Duterte. Why should China jeopardize those ties by having its vessel deliberately ram a Filipino fishing boat?

Unfortunately for bilateral ties, there are possible answers to that "why" – foremost of which is that Chinese maritime militias are on a mission to enforce their nine-dash-line claim over nearly the entire South China Sea, and the Philippines is in the way.

The claimed area includes Recto or Reed Bank off Occidental Mindoro, over which the Philippines was awarded sovereign rights by the United Nations-backed Permanent Court of Arbitration, based on the UN Convention on the Law of the Sea or UNCLOS.

In accordance with that ruling, the Philippines has exclusive economic rights over Recto Bank. Chinese boats aren't even supposed to be there, although of course Beijing does not recognize the arbitral court ruling even if it is a signatory to UNCLOS

if it is a signatory to UNCLOS.

That "why" also does not address the abandonment of the Filipino fishermen in the water after their boat was hit. Beijing has retracted its initial claim that the Chinese ship had fled to avoid a swarm of other Filipino vessels in the area. Even without the satellite images belying this story, the narrative still stretched credulity. If there was indeed such a swarm, why did it take four hours for the fishermen to be rescued – and by a Vietnamese boat? (The Vietnamese weren't supposed to be in our economic zone either, but Filipinos are grateful that they were.)

A joke that went around last Tuesday was that the 22 Filipino fishermen might soon be included in the matrix of individuals supposedly plotting to oust President Duterte. This was fueled by Duterte's statement that critics considered to be dismissive of the plight of the 22 fishermen.

Duterte's spokesman Salvador Panelo has a point in stressing that conflicting statements must be reconciled, especially on such a diplomatically sensitive issue as this one. Panelo seems impressively prescient; certain details in the fishermen's story that he questioned were among those that were changed the next day in the *Gem-Vir* captain's narrative.

Malacañang may want to pay attention to public sentiment about a Chinese invasion of sorts. All over Metro Manila, Chinese enclaves are sprouting, with buildings rapidly being constructed for online gaming activities, supported by grocery stores and Chinese-only dining places.

Being part-Chinese, I should be glad to see my mainland "cousins" swarming (that word again) all over Metro Manila. But this does not stop a Filipino like me from questioning the cousins' exclusivity and disregard for the requirements of doing business in my country.

Now they are not only disregarding our sovereign rights over Recto Bank, but also (if the original *Gem-Vir* story is accurate) leaving our fishermen to the mercy of sharks.

On Wednesday, passions were tempered by reports of the Philippines' official response to the incident: Foreign Affairs Secretary Teddyboy Locsin had brought it to the attention of the United Nations in New York, during a gathering to mark the anniversary of UNCLOS.

Locsin said abandoning people in distress at sea was a "felony" and a contravention of UNCLOS, to which both the Philippines and China are signatories.

Panelo, who has been previously contradicted by Locsin, said the next day that abandonment at sea is OK if the potential rescuers themselves face threats. But Beijing has already retracted the story of the Chinese vessel fleeing because it was "swarmed" by Filipino boats.

Prof. Rommel Banlaoi, president of the Philippine Association for Chinese Studies, says he has reached out to his friends from the Chinese mainland following the Recto Bank incident.

the Recto Bank incident.

Facing us on "The Chiefs" this week on Cignal TV's One News channel, Banlaoi stressed that the two countries have many areas of cooperation that must not be jeopardized by the Recto Bank incident.

But at the same time, he said, "we want accountability, we want compensation for the fishermen, and we want the (Chinese) activities to stop."

Will the crew of the Chinese fishing boat be penalized? Will they be hailed as heroes by Beijing for staking their claim in Recto Bank? Will they be promoted in the Chinese People's Armed Forces Maritime Militia?

The US Defense Department's 2018 annual report submitted to Congress notes that this militia, placed some months ago under the Chinese military, is unique in the world, carrying out "confrontational operations short of war" in pursuit of Beijing's geopolitical objectives in the waters around China.

After initially renting small boats from private fishing firms, Beijing decided to build its own ships with built-in arsenals for its maritime militia. Banlaoi said the provincial government in Hainan now has 84 of these vessels.

One of those vessels is believed to have hit the *Gem-Vir*. What would Chinese accountability entail? Banlaoi replied: an apology from the Chinese boat crew and their identification, so that Filipinos will know how Beijing would deal with them.

"I tell my Chinese friends it's triggering our patriotism," Banlaoi said. "It's uniting us."


