"This situation constrains us to make this explanatory report to these stakeholders, namely our worried employees, our communities, our stockholders and investors, our retirees, our partners and partner banks, and our services and goods providers," Yap added.

The DENR last week released the results of metallic mines passed the review.

the companies recommended for suspension,

saying that the company's treatment, storage and disposal facility for detoxification process for the mill tailings was unregistered.

The government also cited alleged accidents in the mining operations and its low performance in tree planting.

Yap said Lepanto had not received any official communications for the suspension of its operations.

"There is no reason to suspend our operations. We passed the recent audit of all mines ordered by the DENR, which in our case was completed on August 14, 2016. The DENR audit report confirms that we have complied with all relevant laws and regulations," Yap said.

He said the company planted 6.5 million over its area of operations in the last 50 years, and obtained an ISO 14001 certification for its environmental management system.

"For the last 80 years, Lepanto did much more than produce copper, gold and silver. We helped build Mankayan, Benguet into a first-class municipality. We have been dutifully paying our taxes," Yap said.

Lepanto: We're compliant with mine laws

LEPANTO Consolidated Mining Co., one of the companies recommended for suspension by the Department of Environment and Natural Resources (DENR), said it has complied with all mining and environmental laws thus its operation should not be halted.

"This situation constrains us to make this explanatory report to these stakeholders, namely, our worried employees, our communities, our stockholders and investors, our retirees, our partners and partner banks, and our services and goods providers... Lepanto's operation has not been suspended. We have not received any official communications to that effect," Bryan Yap, Lepanto president and chief operating officer, said in a statement.

Yap added there is no reason to suspend the company's operation as it passed the audit ordered by DENR which was completed last August and confirmed that it complies with all relevant laws and regulations.

The DENR said last week the company has to resolve issues like the treatment,

storage and disposal facility; the occurrence of various accidents; and low tree planting performance.

"We have also recently obtained an ISO 14001 certification for our environmental management system. For the last 80 years, Lepanto did much more than produce copper, gold, and silver," Yap said.

"We helped build Mankayan, Benguet into a first class municipality. We have been dutifully paying our taxes... We have planted 6,500,000 trees in the community in the last 50 years. Our livelihood programs and scholarship grants have benefitted thousands of community members," he added.

Lepanto said it supports over a thousand employees enjoying free housing, hospitalization, electricity, and water at the mine site aside from building establishments and infrastructures for the community near the mine site.

DENR gave the firms facing possible suspension a week to explain their sides before a final decision will be made whether their operations will be put to stop.

Audit confirms Lepanto compliant, no reason to suspend ops

AMID concerns on the status of its operations, listed firm Lepanto Consolidated Mining Co. on Monday assured its stakeholders that the company passed the recent audit of all mining companies ordered by the Department of Environment and Natural Resources (DENR).

In a statement, LCMC president and chief operating officer Bryan Yap said that the DENR has no reason to suspend its operations, noting that the audit report confirms that Lepanto has complied with all relevant laws and regulations.

"Lepanto's operation has not been suspended. We have not received any official communications to that effect," Yap said.

Yap issued the statement following numerous inquiries and expressions of concern from nervous stakeholders after news reports came out that Lepanto was under threat of suspension.

"This situation constrains us to make this explanatory report to these stakeholders, namely, our worried employees, our communities, our stockholders and investors, our retirees, our partners and partner banks, and our services and goods providers," he added.

The Chamber of Mines of the Philippines (COMP) earlier scored the DENR for its reportedly reckless public pronouncement about the results of the mine audit despite the premature results of its findings.

COMP also expressed concern over the repercussions of such pronouncements, stressing that the report that was released was highly inconsistent with the letters sent to certain companies informing them of the audit findings.

The mining lobby group also said that the repercussions go well beyond mining communities and further endanger investments in and out of the mi nerals development industry.

"A lot of those companies with alleved viola-

Lepanto is among the 22 members of COMP that have already secured ISO certification, which Environment Secretary Regina Paz Lopez earlier said was "a way to identify responsible miners."

Meanwhile, Yap assured stakeholders that the company will be taking all steps necessary to ensure that they can and shall continue their mining operations and that Lepanto will uphold its legacy of responsible mining.

Lepanto Consolidated exec: DENR has no reason to suscenti company sojne attions

EPANTO Consolidated Mining Co. on Monday said the Department of Environment and Natural Resources (DENR) has no reason to suspend the company's mining operation.

In a statement, Lepanto Consolidated President and COO Bryan U. Yap said that, since the DENR's announcement of its mine-audit report and news of the company's having been under threat of suspension, it has received numerous inquiries and expressions of concerns from stakeholders on the status of its operation.

Environment Secretary Regina Paz L. Lopez said last week that based on the findings and recommendations of the audit teams, 20 more operating mines face possible suspension for failing to meet environmental standards. This brings to 30 the total number of mines that failed the audit criteria, with only 11 of the 41 operating mines being allowed to continue operation for committing minor infractions that do not warrant a show-cause order.

However, as of Monday, the DENR has yet to issue an official letter communicating, the result of the mine audit and furnish the mining companies copies of the reports.

DENR Sénior Undersecretary Leo L. Jasareno said they are in the process of producing copies of the audit reports, particularly the 20 mining operations facing possible suspension.

The DENR would reproduce 2-inch thick individual audit reports for all 41 mining operations seven times—one each for the members of the audit teams, plus another for the mining company.

Yap said the company has not received any official communications to that effect. Secondly, Yap said there is no reason to suspend the company's mining operations.

"We passed the recent audit of all mines ordered by the DENR, which, in our case, was completed on August 14, 2016. The DENR Audit Report confirms we have complied with all relevant laws and regulations," he said.

Yap added that the company also recently obtained an ISO 14001 certification for environmental management system.

Community impact key to new mine permits

THE Department of Environment and Natural Resources (DENR) said it wants mine operators left untouched by a recent audit to prove their effectiveness in boosting socioeconomic activity in their host communities before new projects are approved.

ones until we show that we can do it well... Miners right now are not doing a good job," Environment Secretary Regina Paz L. Lopez said in a phone interview on Monday.

Aside from ordering the review of operations for 41 metal miners, Ms. Lopez in a memorandum order issued in July also put a halt to new mining applications.

Asked on the prospects of lifting the moratorium she imposed, Ms. Lopez said: "No, not now. We should fix it first. I mean, the fact that 30 failed the audit means we are not in good shape... Why would I allow more new [mines]?"

The secretary said that the agency will consult with stake-holders in presenting a so-called total economic valuation framework that will determine the economic viability of mining projects, according to Ms. Lopez.

A total economic valuation approach will seek to place a value on the negative effects of mining operations, making for an improved estimate of costs and benefits. Environment Undersecretary
Leo L. Jasareno has said that the
agency may release soon an administrative order covering the new
policies, particularly on utilization
of social development and management program funds (SDMP).

Ms. Lopez said that she will support the mining industry in terms of presenting projects in which they can appropriate their SDMP funds in a "creative and cohesive way."

"They don't know how to do development. They know how to do mining. But I know how to do development. That's what I did for 25 years. I know how to use money because we never had a lot of money like them," she added.

Under existing laws, all mineral contractors are tasked to lay out a five-year comprehensive plan, the SDMP, with the aim of improving the livelihood of people in host and neighboring communities.

Miners set aside 1% of their annual direct mining and milling cost, of which 90% is utilized for SDMP and the remaining 10% to develop technology and manpower.

Meanwhile, the Chamber of the Mines of the Philippines (CoMP) expressed willingness to work with the DENR Secretary on improving the utilization of miners' SDMP funds.

"We're very willing to work

Policy Division Ronald V. Recidoro said in an interview, noting, however, that the CoMP has not received from the DENR a formal invitation to discuss the matter with mining stakeholders.

Mr. Recidoro added there is room for improvement in the implementation of SDMP in a way that would expand its benefits to cover whole provinces.

The mining group also opposed an indefinite halt to new mining projects.

According to the CoMP, total projects currently in the pipeline run until 2020 and are expected to bring in at least \$20 billion in revenue.

DENR engages village heads in forest protection



LUCENA CITY, Quezon — The Department of Environment and Natural Resources-Community Environment and Natural Resources Office (DENR-CENRO) in Talipan, Pagbilao has forged strong partnerships with barangay officials in a bid to boost forest protection in this part of the province.

At present, village officials conduct periodic upland monitoring in their respective areas of jurisdiction to ensure that no illegal logging, "kaingin" (slash and burn), and other forms of forest destruction are pernetuated."

DENR-CENRO Officer Ramil Limpiada said that deputizing village chiefs is provided in Executive Order No. 23, which primarily declares a moratorium on the cutting and harvesting of timber in natural and residual forests. It also mandates the creation of the Anti-logging Task Force.

The primary purpose of these moves, Limpiada said, is to task village chiefs, in particular, to raise awareness, funds, and resources for tree-planting.

A memorandum of agreement (MOA) which was prepared by DENR-CENRO was signed, by the presidents of Association of Barangay Captains (ABC) of towns covering the DENR-CENRO Pagbilao, to hold responsibilities in the protection and prevention of illegal logging and other forest destruction.

They have the authority to arrest suspected illegal loggers and confiscate undocumented logs.

The power of outreach

ULTI-Sector Governance Coalition (MSGC) members, with active support from the city's many Value-Aligned Circles (VACs), use their networks in order to spread the reach of the city's governance programs. Moreover, they take advantage of the presence within the city of national government agencies that have their regional offices in Butuan for the Caraga region.

The involvement of the Philippine Army and the PNP in the initial tree-planting activities at the Bood Promontory and Eco Park has already been mentioned. In the Caraga Eco Park, in addition to the Caraga State .University, at least three other national government agencies are involved: DTI, DA, and DENR. The Caraga State University happens to have a 200-hectare campus, which is just 4 kilometers from the city proper: it has reserved ample space within its property for the "expansion and re-packaging of an existing biodiversity conservation project" of the university. Within this reserved site, some 2,000 trees belonging to

several indigenous tree species have been planted to form a "naturally-set rainforest ecosystem."

Through the MSGC, arrangements have been made to make this eco-park open to the general public. The city is now involved in its further development; it has thereby acquired one more site to add to the cluster of pocket forest parks called for by its Vision 2020. This is an example of the pro-active stance the city has taken in engaging external stakeholders who can help put up projects in pursuit of the city's vision.

Another outreach program is directed to the city's barangays. Outreach to barangays goes beyond getting them to participate in the tree farming and growing initiative of the city. It extends to getting the barangays "embrace Vision 2020" such that they (the barangays) would "replicate many of the programs and projects" included in the city's performance scorecard. This outreach program to barangays would entail the following:

• Help the barangay craft its own Strategy Map that would be fully supportive of, and fully in line with, the city's own Strategy Map.

Through technical assistance

from the city, orient the Punong Barangay and the Barangay Council towards using the city Strategy Map as a reference for its own "planning, resource mobilization, and monitoring of identified development projects."

One specific example of a barangay that has already done so is Barangay Doongan. It now has 10 major programs that it has launched to make it "socially and economically competitive," such that "equal opportunities" would be open to "all barangay stakeholders." The city provided

further technical assistance so that the barangay would have "access to funds from other line agencies (of the national government) that have related programs" (to those of the barangay); sometimes, this would entail having "to customize the barangay projects to fit the requirements of the funder." Technical assistance extends to enabling the barangay to "tap private partners (willing and able) to provide technical support, manpower and financial assistance for the (barangay) projects."

It is true that one swallow does not bring in the summer, and that one barangay does not portend similar success involving other barangays. But the mold has been made, and this success story—in the case of Barangay Doongan—can now be replicated in the other barangays of the city. The city's VACs and MSGC members have a concrete success story they can tell to others who may then follow in Doongan's wake.





Lego bricks, metal strands may have choked beached whale in Davao

DAVAO CITY - Interlocking plastic bricks, more popularly known as Lego, and strands of metal may have caused the death of a short-finned pilot whale which was found on a beach on the southern part of this city Sunday.

Darrel Blatchley, an expert in marine mammal beaching, told reporters Monday that an initial autopsy of the whale showed that it had ingested the foreign materials, which may have been floating in the Davao Gulf.

The beached whale was found in Kadatu Beach, Pag-ibig Village in Barangay Dumoy here.

Blatchley, the American curator of D'Bone Collector Museum here, said the whale that was found dead Sunday was the third to have been beached in the scene last Sunday, the whale was already in a state of decomposition, which led the team to conduct an autopsy on the spot.

Its tail had also been cut off, but Blatchley said that this could have happened along the Davao Gulf.

According to Blatchley, the whale may have died of starvation of dehydration

The whale weighed at least 400 kilograms and would have been at least 13 feet long, Blatchley said.

Some of the whale's teeth were also gone that led Blatchley to surmise that these were plucked by curious locals or beachgoers who were after souvenirs.

Possession of any part of protected creatures is prohibited by law.

Pygmy sperm whale rescued in La Union

SAN FERNANDO CITY, La Union: A 6.5-foot long pygmy baby sperm whale was rescued over the weekend by the La Union Rescue Team, Bureau of Fisheries and Aquatic Resources and the City Fisheries and Aquatic Management Council (CFARMC) from coastal area in Carlatan Village in his city.

The sperm whale, which weighed 1,000 kilograms, had swum toward the shore and was discovered by a local fisherman who lives nearby.

According to Dr. Chris Apilado, a CFARMC veterinarian, the whale bore two deep cuts, one near an eye and the other on the tail.

"Maybe it was caught and was being fished out from the water by handy fishing hook but it was able to wiggle out," Apilado said, who closely examined the injuries while the sperm whale was still floating in the water.

Vanessa Bonitalla said her fisherman husband, Ding Carpio, saw the mammal at about 4 a.m., Friday, as soon as he woke up.

They rushed to the sea and were surprised to see an injured "dolphin" and tried to push it farther into the sea but it cannot move so they called for help from village guards.

Sally Gacayan, a BFAR staff, said the sperm whale would be brought to the BFAR custodial quarters in Casantaan village in Santo Tomas, La Union.

Gacayan said they would try to keep the mammal alive by first treating its wounds until it is strong

enough to be released into the sea.

A vehicle from the La Union Provincial Disaster Risk Reduction Management Council transported the injured whale, which was placed in a rubber boat filled with sea water.

The pygmy sperm whale is one of the several aquatic species that is endangered.

It was the second stranded whale found in the coastal area.


In October 2014, a 12-ton, 20-foot long giant sperm whale, died while it was being rescued by a backhoe and burly men at the near by village of Lingsat Marine Sanctuary.

It was eventually buried in village.

In 1909, the University of the Philippines

College of Agriculture was established at the foot of Mount Makiling by the American colonial government to promote agricultural education and research in the Philippines. In 1933, the Makiling Forest Reserve was made into a National Park under the care of Bureau of Forestry. In 1960, the administration of Makiling National Park was transferred to the University of the Philippines for forestry education and research purposes of the College of Forestry.

At present, the University of the Philippines Los Banos (UPLB) is the designated caretaker of the 4,347-hectare Makiling Forest Reserve. The reserve is home to diverse flora and fauna. The forest serves as the laboratory to students and researchers. It is also open to nature lovers, adventure seekers and conservationists.


How to get there

Being under the jurisdiction of UPLB, the only way to go to Mt. Makiling is to enter the gates of the university.

For those driving to Mount Makiling, take

the south highway via SLEX then exit from Calamba, also in Laguna. From Calamba, continue drive to the national highway all the way to the next town of Los Banos. The main entrance is 1.3 kilometers from the Jollibee junc-

What to do, what to see

Mount Makiling's peak can be climbed in a day. Although there are several designated campsites for those who prefer to stay overnight, it is not advisable because of limited water source and presence of "limatiks" (forest leech) at higher elevations.

There are several access trails to Mount Makiling, but the most popular is via UPLB. All visitors to the Mount Makiling Forest Reserve are required to register at the entry point and pay P10 per person entrance fee. The entry point is marked Station 1, and all important landmarks are properly identified, making the need for a hiking guide unnecessary.

The next major station is the entrance to the Makiling Rainforest Park (Station 7). The trail leading to the park is 3.3 ki-

lometers from the gate, and takes between one to two hours of easy to moderate trekking. Here, there is a huge camp site for overnight hikers. Located also within the vicinity are the UPLB Nursery Farm and the Mud Spring (about 15-minute trek from the main trail).

From here, one can take a short detour to the Mudspring before taking the two-hour trek to the summit. The summit is identified as Peak 2, and it rewards climbers with a magnificent view of Laguna and its surroundings.

But for those who do not wish to tire themselves but still like to see the many trees that grow in Makiling, they can visit the Botanic Garden near the entrance of the reserve. Established in 1965, this natural museum contains many plant species endemic to Mount Makiling.

Another interesting site around Makiling is the National Center for the Arts. Built

during the Marcos regime, it continues to hone talented students through the Philippine High School for the Arts. On the way up to the center, visitors will pass by the Chapel of Saint Marc. The chapel's cross – featuring the outline of a crucified Christ – was designed by National Artist Leandro Locsin.

At the main campus of UPLB, visitors can also see the Oblation, the old Baker Memorial Hall, the Carabao Park, the Carillon Tower, the Seniors Social Garnden and many more. At the corner of the football field is the biggest Acacia tree in the campus. It is also called Fertility Tree because of the many things that happen at night under the tree.

Where to stay, what to eat

As most visitors to Mount Makiling go there for a day trip, places to stay overnight are very limited. There is a designated campsite

at the Rainforest Park. However, prior arrangement must be made at the gate.

Visitors can also stay at the Pook ni Maria Makiling right next to the Jamboree site. It is also possible to find overnight lodging at the cottages of the National Arts Center.

Another alternative is to stay overnight at the nearby Pansol, where private pools with cottages can be rented for P5,000 to P10,000 for 12 hours.

There are many places to eat around UPLB. For quick and affordable meals, visit the campus cafeterias. For those who wish to try some authentic Elbi (LB) cuisine, the stretch from Jollibee junction to the main gate are lined with quaint little restaurants ranging from Thai to Mediterranean that serve tasty and reasonably fair-priced meals.

But for the ultimate Elbi experience, try the choco milk being sold at the Dairy Farm. It's as fresh and as refreshing as the popular Mount Makiling.
